The tenure of the officers selected to the post of RSO with CBI should normally 4 years.

Normally, selection should not be made of those officials who have already served in the CBI and have come back to Railways.

In this connection, service particulars of the applicant showing educational qualifications, services in various posts and ranks, experience, present pay and allowance, scale of pay in which the pay is being drawn, whether permanent or temporary, must be submitted with the application and these particulars should be verified by the forwarding authority.

The staff recommended should have clear current DAR/SPE & clear Vigilance history .
