A. The engagement of Clinical Psychologist in Divisional Railway Hospital/Solapur (Central Railway) may be engaged on Contract basis from Open Market who fulfil the eligibility conditions, through Walk in-Interview".

B.CONDITIONS FOR ENGAGEMENT OF CANDIDATES FOR CONTRACT CLINICAL PSYCHOLOGIST FROM OPEN MARKET: Applications are invited from Indian citizens for the post as mentioned herein. Eligible candidates having the following qualifications, experience and fulfilling other terms and conditions may appear for the interview. Application in prescribed format /Annexure-I) along with all relevant certificates/testimonials in Original and attested copies of each are required to be produced by the candidate at the time of Interview.


C. Age: i) Age between 18-33 Yrs. However, relaxation of upper age limit of 5 years for SC/ST, 03 years for OBC (NCL) candidates is allowed. ii) Age will be reckoned as on the date of issue of this notification.

D. Duties of Clinical Psychologist: 1. Psychological Assessment and diagnosis. 2. Counselling and cognitive behavioral therapy (CBT). 3. Developmental assessment of toddler, children. 4. Intelligence assessment in children and IQ certification. 5. Disability assessment. 6. De-addiction therapies for substance abuse people. 7. Diagnoses or evaluates mental and emotional disorders of individuals and administers programs of treatment, interviews patients in clinics, hospitals, and other settings and studies medical and social case histories. 8. Observes patients in various situations; selects, administers, and interprets intelligence, personality, or other psychological tests to diagnose disorders and formulate plans of treatment, and provides consultation to other mental health professionals with regard to test results. 9. Treats psychological disorders to effect improved adjustments utilizing various psychological techniques; selects appropriate treatment approach and plans frequency, intensity, and duration of individual, group, and family therapies. 10. Assesses patient progress and modifies treatment programs accordingly; communicates with and counsels family members as appropriate. 11. Documents therapy in accordance with policies and procedures regarding medical records; implements and adheres to policies which ensure patient confidentiality. 12. Provides crisis intervention in situations requiring immediate psychological treatment.




13. Participates in educational programs, in-service meetings, clinician meetings, and workshops to enhance professional development and maintain currency of methodology and techniques. 14. May instruct and direct students serving psychological internships in hospitals and clinics. 15. Provides psychological consultations to other mental health professionals within hospitals, clinics, and other community based agencies with regard to clients and/or patient care. May develop and implement clinical research program. 16. Perform the other duties assigned by Medical Officer/Dept In-charge of Psychiatry.

E. Other terms and conditions: 1. The place of working is "Divisional Railway Hospital/Solapur (Central Railway)". 2. The appointment is purely on contract basis at fixed remuneration & Full time contract, no further claim for continuation will be entertained. 3. The candidates are not entitled for any other benefits like house rent allowance, dearness allowance, city compensatory allowance travel benefit etc. 4. The candidates appointed will have to produce the qualification certificate as well as Registration certificate from National or State level councils. 5. NOC from current employer. 6. Private Practice will not be allowed. 7. Candidates appointed on contract with the Railway will not have any claims or right for his/her continuity in service or automatic extension of the terms on the contract. These services will be terminated at the end of the contract period or availability of Regular candidate. 8. The initial engagement of the selected candidate will be purely on contract terms of maximum period of one year subject to continuation of the scheme beyond 31.12.2023 or till the vacant posts are filled up by RRB candidate whichever is earlier. The engagement of the above candidate is a stop gap arrangement and will not count as a service. Extension beyond 31.12.2023 will however, be subject to continuation of validity of the scheme by Railway Board. 09. The working hours will be as per the working hours of Divisional Railway Hospital, Solapur as per exigency of service. 10. Working will be 6 days (except NH) per week with weekly rest on Sunday. 11. All the candidates should have good physical sound mental conditions as per Railway Medical Standards and they will be subjected to Medical Examination as per extant Railway Rules and those who are found fit in the prescribed medical examination will be engaged on contract terms. 12. Candidate selected will have to undergo preliminary professional evaluation and verification of required documents by committee of officers nominated by Competent Authority. 13. In case of unsatisfactory work or misconduct on the part of the personnel so engaged on contract basis, Railway reserves the right to terminate the contract at any time without assigning any reasons thereof. 14. There may be waitlisted/standby panel of candidates over and above the posts disclosed in the notification. They may be or may not be engaged as per administrative requirement. 15. The monthly remuneration will be Rs 35,400/- (Admissible Allowances) per month for full time contract Clinical Psychologist. 16. They will not have any prescriptive right to claim for regularization (or) absorption into Railway service. The candidates have no right to claim for automatic renewal of the contract after completion of the contract period and also have no right for automatic regularization (or) absorption in Railways. It may be noted that it is at the sole discretion of the Railway administration whether to renew the contract or otherwise. 18. During the validity of the contract, the Railway administration reserves the right to terminate the contract by giving 15 days notice or wages in lieu thereof, without assigning any reason whatsoever. The contract shall also be terminated forthwith, if the work of the contractual staff is found to be unsatisfactory or conduct is unsatisfactory (or) found to be mentally / physically incapacitated. 19. In case the engaged contract staff remain unauthorized absent for more than 15 days, it will be presumed that such staff has submitted their resignation, and their service will get automatically terminated from the 16th day onwards and they will not have any prescriptive right to claim for joining the contract service.



20. Candidates proposed to be engaged on contract basis will be subjected to screening test and Medical Examination and should be found fit in the prescribed Medical classification. 21. It may be noted that the notification is governed by all the Railway Boards instructions issued from time-to-time in regard to engagement of contract Clinical Psychologist, and shall be abide. The railway administration reserves the right to cancel, amend or otherwise modify all or any of the terms and conditions of this notification without assigning any reasons thereof. 22. A detailed contract agreement" will have to be executed by the candidate on their successful selection. 23. The detailed instruction with regard to duties while in contract with Railways shall be given to candidate in the event of selection and subsequent signing of Contract Agreement. 24. During the validity of the contract, the candidate will be at liberty to terminate the contract for betterment of his/her career or any other grounds by giving prior 30 days notice to the Railways. 25. The Selected candidate will be governed by the instruction issued by Railway Ministry/Railway Administration for grant of leave and other privileges etc. 26. The Divisional Railway Hospital/Solapur (Central Railway) Administration reserves right to deploy the candidate in any area depending upon the exigency of the service and refusal or otherwise will be deemed as misconduct on the part of the candidate. 27. The candidates are personally responsible for payment of Professional tax, Income tax and other duties/taxes leviable by the State/Central Government from time to time. 28. It is important to note that the police verification of the antecedents of the contractual staff so engaged will be done regularly to ensure law and order. In case, any of them found indulged in any criminal activity, necessary action will be taken as per IPC. 29. SC/ST/OBC candidates should submit a self attested copy of their caste certificate issued by the Competent Authority in the prescribed proforma. The OBC candidates must ensure non-creamy layer (NCL) certification. Such certificates should be latest one, but not be more than one year old at the time of document verification. 30. EWS candidate should fulfil the eligibility criteria as mentioned in the O.M.No.36039/1/Estt. (Res), dt 31.01.2019 issued by Ministry of Personnel, Public Grievances & Pensions, DoP&T., Govt, of India. 31. The day(s) of interview will be intimated separately and may be more than one day. 32. No TA/DA/ Accommodation will be provided to the candidates attending the interview.
