Subject: Norms/Criteria for posting of PED/Vigilance/RB, AGM, SDGM and ADRM - regarding.

Railway Board have decided that norms/criteria for posting of PED/Vigilance/Railway Board, AGM, SDGM and ADRM will be as under:

Post	Norms/Criteria
AGM, SDGM & PED/Vig/RB	Board have decided that for posting as AGM, SDGM & PED/Vig/RB, requirement of having worked as DRM shall not be the eligibility criteria. However, preference will be given to officers who have worked as DRMs.
ADRM	Board have decided that for posting as ADRM, the benchmark would be 43 marks in preceding 5 years' APARs. Officer should have earned at least 8 marks in each year's APAR and should be clear from vigilance angle.

2. All other conditions remain unchanged for postings as AGM, SDGM, PED/Vig/RB & ADRMs.
3. Railways/PUs/CTIs are requested to bring the above norms/criteria to the notice of all the officers.
