(Commercial Circular No. 01 of 2024) (Corrigendum to CC No. 07 of 2023)

Sub: Earmarking of reservation quota for persons with disabilities (PwD) in reserved Second Sitting (2S)/air-conditioned Chair Car (CC).

Please refer to this office letter of even number dated 31.03.2023 (Commercial Circular no 07 of 2023) wherein it was advised that the following reservation quota should be earmarked for Persons with Disabilities (PwDs) and their attendant in those Mail/Express trains in which PwDs have been allowed to book reserved ticket on concession:-

- i. Four berths in Sleeper class (two lower and two middle).
- ii. Two berths in 3AC (one lower and one middle).
- iii. Two berths in 3E class (one lower and one middle) (in those trains in which there is no 3A class and only 3E class coaches have been attached).
- iv. Four berths in SLRD coach of Garib Rath Express trains on full fare. (two lower and two upper)
- v. Two seats in reserved Second Sitting (2S)/ air-conditioned Chair Car (CC) in those trains which have more than two coaches of these classes.
- 1.1 The matter has been reviewed and it has now been decided that the following reservation quota meant for PwDs should be earmarked for PwDs in all reserved Mail/Express trains including Rajdhani/Shatabdi type trains viz. Rajdhani, Duronto, Vande Bharat, Humsafar, Gatimaan, Special trains on special fare etc. irrespective of the fact whether concessional fare facility is available to PwDs in such trains or not:
  - i. Four berths in Sleeper class (two lower and two middle).
  - ii. Four berths in 3E or 3A class (two lower and two middle).(The class out of these two i.e. 3E/3A in which quota is to be earmarked can be decided by zonal Railway concerned keeping in view the number of coaches of that class available in the train.)
  - iii. Four berths in SLRD coach of Garib Rath Express trains.
  - iv. Four seats in reserved Second Sitting (2S)/ air-conditioned Chair Car (CC) in those trains which have more than two coaches of these classes (except Vande Bharat Express trains).
  - v. Four seats in Vande Bharat express trains.

(Specially designed Seat no. 40 in coach no. C1 and C7 in case of 8 car trains and seat no. 40 in coach no. C1 and C14 in case of 16 car trains for PwDs and one seat each adjacent to these specially designed seats for the escorts of PwDs)

- 1.1.1 Concessional fare facility shall be governed by the extant guidelines issued from time to time.
- 1.1.2 With a view to avoid misuse of this provision, facility of booking ticket under this quota online will be available only to those PwDs who have been issued unique ID card by the Railways. For booking tickets across the counter, this facility shall be available on production of unique ID card issued by the Railways or the copy of concessional certificate in prescribed proforma as per existing Railway Rules applicable for issuing concessional tickets. This facility will be available only at those reservation counters where concessional ticket booking facility is available.
- 1.2 CRIS will make necessary modifications in the software accordingly to ensure verification of unique ID card issued to PwDs by the Railways even in those trains where concessional fare facility is not available. Whenever an eligible PwD as per Railway Rules books a ticket against this quota in a train in which concession is not admissible to him/her, a pop-up message should be displayed informing that concessional fare facility is not available in this train. CRIS shall also ensure that whenever a PwD books a ticket in Vande Bharat express train, he/she should be booked on the specially designed seat no. 40 in coach no. C1/C7/C14, if available and their escort should be booked on the seat adjacent to these specially designed seats earmarked for PwDs. In case both of the specially designed seats earmarked for PwDs in Vande Bharat express trains have been booked by PwDs but one or both of the seats earmarked for their escort are vacant, the vacant seat(s) can be allotted to a PwD.
- 1.3 Wide publicity about this provision should be given through all available means for information of general public.
- 2. Necessary instructions may be issued to all concerned accordingly.
