3. **Eligibility** :-  
Erstwhile Gr.D staff with GP -1800(6<sup>th</sup> PC), of all Departments having completed atleast 2(Two) years in Railway Service (as on the date of issuing notification), can apply for the subject post.
4. **Selection Procedure** : for Selection of Office Peon, a screening /suitability will be taken.
5. **General Conditions**:-
  - 1) Application/s should be forwarded through proper channel. No direct applications will be entertained in this office
  - 2) The applicant should apply as per proforma enclosed.

- 5) The selected candidates may be repatriated to parent department at any time, if it becomes necessary for the administration, without assigning any reason.
- 6) Once selected, applicants will not be permitted to withdraw and refuse posting in Vigilance Department.
- 7) The staff should have clear Vigilance history.
- 8) The date of viva-voce / screening/ suitability test shall be intimated to the eligible candidates later.
- 9) Notified Vacancies are tentative and may be increased or decreased during the selection procedure as per requirement of administration.

Original service register and attested Xerox copies of **Working Reports** for the last three years 2020-21, 2021-22, 2022-23 of the candidates should be sent to this office for selection.
