- The final Answer Key along with "decision on the representations received regarding wrong key answers OR the decision in case of discounting any questions OR in case of incorrect wording of question/s" will be published on railnet within the period of 03 working days.
- The decision of the Paper Setting officer will be final and no further correspondence in this regard will be entertained.


