Sub: Selection for one 'ex-cadre' post of Presenting officer in M/L- 7 (7th PC) Non-Gaz.,
in Vigilance branch/HQ/Central Railway.

It has been proposed to call for applications from willing Railway employees of Central Railway for selection of 1(One) 'ex-cadre' post of **Presenting Officer (P.O.)** Non-Gaz. in Matrix Level-7 (7th PC), on tenure basis, for working in Vigilance deptt. Of Central Railway, CSMT, Mumbai.

The post is ex-cadre with normal tenure of three years from the date of induction and the administration reserves the right to repatriate the staff to the respective parent cadre on the Railway on or before completion of the tenure without assigning any reason whatsoever.

Selection Process:-


Selection to the posts of PO will comprise viva-voce/APARs/ credibility. Date of viva-voce will be informed in due course.

Eligibility:-

- 1) The candidate should be working in substantive Level-7 of pay matrix (7th PC); GP-4600 (6th -PC) or upto one level below i.e. ML-6 on regular basis (not under MACP).The staff working in ML-8 will also considered eligible and if selected then the concerned unit / department to transfer the employee along with ML-8 element of the post to Vigilance department temporarily.
- 2) Should have completed 5(five) years' service (as on date of issuing the notification).
- 3) The candidate must have experience in dealing with D&AR cases.

General Conditions

1. Applications must be forwarded through proper channel.
2. Application should be made as per proforma enclosed and must be filled and signed by the candidate himself/herself giving the correct information best to his/her knowledge, especially regarding SPE/Vigilance/DAR cases. No alterations/correction on the application will be entertained. Applicants must note that if any information furnished by him/her are found to be false at any stage, the application/candidature will be summarily rejected. Submission of false or misleading information by applicant will lead to DAR action. The particulars as submitted by the applicant in his/her application must be Verified and signed by the concerned Supervisor, clearly mentioning own name & designation and office. While verifying the application, any additional information

/alteration / correction, remarks made must be signed with date, name and designation by the verifying Authority. For correctness of the information concerned office will be solely responsible and no way Vigilance deptt. will have any responsibility in this regard. Forwarded application must have signature, stamp and office seal of the competent authority.

3. The staff should have sound integrity, should not be figuring in any current Vigilance/SPE/DAR case and should not have been imposed any major/minor penalty in any past Vigilance case.
4. Past record of Vigilance case would debar the candidate from the selection.
5. The staff should have good reputation and possess good writing ability. Candidates having Computer knowledge will be given preference.
6. The staff should possess sufficient knowledge of Railway Service (Conduct) Rules and Railway Servants (Discipline and Appeal) Rules.
7. The applicants may be specifically advised that the post of **Presenting officer** is a tenure post for three years, but the Vigilance organization reserves the right to repatriate him even earlier without assigning any reason in the case of selection/promotion to the higher grade post.
8. The incumbent will not be eligible for any honorarium during his/her tenure as P.O.
9. Attested Xerox copies of APARs for the years 2019-20, 2020-21, 2021-22 and 2022-23 of the applicants may please be sent to this office along with the application forms.
10. The candidates whose names have been recommended should be relieved immediately in event of his/her selection as **Presenting officer**.
11. Once selected, applicants will not be permitted to withdraw and refuse posting in vigilance department.
12. No direct applications will be entertained in this office.
13. Forward the applications of those employees who have fulfilled the aspect as per APO (Ruling/Admn.) HQ letter no. CR-HQ/PERs(PUPM) /4/2023/310136 dated:- 07.03.2024 regarding 'cooling off period' from one ex-cadre post to another ex-cadre post in Central Railway (**Copy enclosed for ready reference**). Also check and certify the above aspect while forwarding the applications of the employees.


It is requested to give wide publicity to this notification, so that eligible candidates can benefit from this.
