As per Railway Board letter No. 2022/E/(Rep)/Spouse Ground Transfer dtd.20/08/2022 followed by CRB's DO No. 2022/E(Rep) Spouse Ground Transfer dated 06/09/2022 circulated vide this office letter No. P/HQ/Ruling/O/811 dtd.19/09/2022 the condition of relieving the group 'C' employees on Inter Railway and Inter Divisional Transfer after approval of concerned PHOD, wherever the number of vacancies are more than 10% in the cadre, was temporarily withdrawn for the purpose of own request transfer on spouse ground only as a onetime measure.
