In case of non-availability/not having enough options of candidates from higher grade post, employee in lower grade may be considered against downgraded vacancies. 5. The option may be sent as per enclosed Proforma, duly forwarded by cadre controlling authority with a certificate that the employee will be spared for posting at ELS/Daund of Pune Division, Central Railway, if found suitable. 6.
