It has been decided to conduct a selection for the Ex-cadre post of Instructors, Level-6 for BTC (Elect.) for the following vacancies:

Applications are invited from willing and eligible staff of respective trades who fulfill the following eligible conditions:-

- The staff off concerned department (Electrical) working as JE (Level-6), Sr. Tech (Level -6) & Tech-! (Level-5) on regular basis as per shop wise vacancies mentioned above. Preference will be given i) first to staff working as JE (Level- 6). If sufficient number of application from JE are not received, only then applications of Sr. Tech (Level-6) & Tech.I
- Staff (Tech.1) should have put in minimum 02 yrs of service on the of issue of notification. ii)
- The candidates should passes degree /diploma in engineering or degree in only faculty along with ITI/NCTVT qualification in the notified trade for which he/she applies. (iii
- The age of the applicant should be below 55 yrs. as on the date of issue of this Notification. iv)

2. Tenure & Lien :-

Tenure -05 years in BTC from the date of their regular selection. Lien of the selected candidates will be maintained in their parent cadre for further promotion.

Selected candidate will be eligible for teaching allowance @ 12% of basic pay or candidates if selected from lower grade will not be eligible for pay fixation in higher grade, but will be eligible for 12 % of teaching allowance on pay of the cadre. (Rly Bd's L.No.EMPP) 2012/3/28 dated 06, 10, 2017.

The post of instructor being Ex-cadre & Tenure post, reservation rules are not applicable & also there is no further avenue of promotion.

5. Other terms & Conditions :-

1) Previously worked Instructors are eligible to apply only after a gap of one year from the date of their repatriation to their parent cadre.

2) Preference will be given to the candidates having graduation, computer knowledge, aptitude for

cultural activity, Degree/Diploma in I.T. etc.

3) Applicant should be a good communicator, sensitive to the needs of people, Resilient, open-minded, perceptive honest committed and motivated. The candidate once selected will be not be allowed to decline the post. However selected candidate may be repatriated before completion of tenure without assigning any reason.

6. In terms of Rly Board's L.No.E9NG) I/2018/PM 1/4 dated 14.12.2018 question paper will be 100% objective type i.e. all question will be of multiple choice.

7. Selection Process:

Written Test (75 marks)-100% objective type question & Classroom lecture Trial (25 marks). Thus the above selection process will evaluate the knowledge as well as communication skill of the candidates as both are required for the post of Instructor.

Maximum Marks -100, Qualifying Marks -60%. There will be negative marking @1/3 mark for a wrong answer.

8. Instructions:

- a) The examination will be in pen & paper mode & candidates should use only one ink Pen.
- b) Answering should be done by the way of bubbling in the supplied OMR sheet.
- c) To ensure authenticity of the answers, cuttings, over writing, erasing or alterations, double bubbling of any type in the answer will considered as wrong answer.
- d) The examination will be of 120 minutes duration.
- e) The question paper will be in Hindi & English languages only.
- f) 10% of the question paper will be on Official language policy & Rules, which will be optional to
- g) Question paper will consists of 110 questions. Candidates have to attempt. Any 100 question.
- h) Any type of revealing identity if written on the answer scrip, such answer script will be declared as invalid without notice.

9. How to apply:-

The candidates fulfilling the eligibility criteria may submit their application in the prescribed proforma enclosed through their respective controlling authority of Division/Depot/Unit/Workshop in duplicate alongwith attested copies of their educational qualification by 03.06.2024.

The immediate controlling supervisors after checking all the data of the proforma application & ensuring it to be in order, will forward the same to the Personnel branch of their respective division/workshop by 06.06.2024.

After verifying the service particulars of each applicant, Personnel Office shall forward the same to CWM/Matunga on before 10.06.2024.

After scrutiny of applications of eligible candidates they will be called for Written Test, it may please be noted that No Supplementary test will be conducted.
