**Sub: Reporting at Railway Board on return from deputation and issue of posting/transfer/promotion order by Railway Board.**

It has been observed that there are some instances of Railway Officers on completion of their tenure at a posting, including that of DRMs and ADRMs, reporting in Railway Board for further posting without any formal orders from Railway Board to this effect.

2. In order to streamline the system of reporting of Railway Officers in Railway Board for posting, it has been decided by the Competent Authority that only those Railway Officers who have completed their deputation tenure in various PSUs under Ministry of Railways, other Ministries/Departments of Government of India, State Governments and other Organisations and their posting orders have not yet been issued, shall report to Railway Board for further posting.

3. In all other categories of cases where officers complete their tenure at a posting in the Railways including that of DRM and ADRM and cases where an officer has been posted against the present incumbent without the corresponding posting of another incumbent, with a direction that orders for the present incumbent shall follow, they shall report to the Head of Personnel branch of the respective Railway/Division/Unit and wait for further posting by Railway Board. The concerned Railway/Unit will intimate this reporting to the Railway Board immediately. All the Establishment matters relating to these officers waiting for orders of posting by Railway Board will continue to be handled by the respective Railway/Division/Unit, till further posting orders are issued by Railway Board.
