1. Vide Ref (iii) above, the case of relieving Shri Susen Biswas, Tech-I on Int Railway own request transfer to Kanchrapara Workshop, Eastern Railway was sent to H for obtaining approval of PHOD as vacancies in the cadre exceed 10%. The case we examined carefully and the following are observed.

1.1 While obtaining approval of GM for forwarding the IRT application on out of tu basis, the fact that there are vacancies exceeding 10% of cadre was taken into consideration and approval of PHOD and GM were obtained taking into consideration this position fact. This office had communicated the approval of GM vide letter quoted under Ref (ii).

As General Manager had already accorded approval for forwarding Inter Railw own request transfer on out of turn basis on the recommendation of PHOD duly taking in consideration the position of fact that the vacancies in the cadre exceed 10%, no furth approval of PHOD is required for relieving the concerned employee provided the staff is Priority No.1 in register.
