Sub: Reservation in promotion to Persons with Benchmark Disabilities (PwBDs) – regarding.

Ref: (i) Railway Board's letter No. E(NG)/I/2019/PM 4/8 dated 01.07.2022 (ii) DOP&T's O.M. No. 36012/1/2020-Estt(Res-II) dated 17.5.2022.

1. Railway Board vide letter No. E(NG)/I/2019/PM 4/8 dated 01.07.2022 have forwarded DOP&T's OM No. 36012/1/2020-Estt(Res.-II) dated 17.05.2022 containing detailed instructions for providing reservation in promotions to PwBDs, in posts and services of the Central Government, as defined under section 2(r) of the PwBD Act, notified by the DEPwD (Department of Empowerment of Persons with Disabilities).

2. As per Para 10.3 of DOP&T's O.M. No. 36012/1/2020-Estt(Res-II) dated 17.5.2022, the Points 1, 26, 51 and 76 of the roster shall be earmarked for PwBDs one point each for category under (a), (b), (c) of Para 2.2 of DOP&T's O.M. dated 17.5.2022 ibid, respectively, and one point for category (d) and (e) conjointly. The Head of the establishment shall ensure that vacancies identified at Sl. No. 1, 26, 51 and 76 are earmarked for the respective categories of the PwBD. However, the Head of the Department shall decide the placement of the selected candidate in the roster/ register. In other words, **the category to be appointed first will be decided by the Head of the Department based on the functional requirement.**

3. Accordingly, to exercise these powers at various levels, it is decided as under:

In HQ Office	Cadre controlling PHOD or HOD
On Divisions	Cadre controlling Branch Officers with the approval of DRM/ADRM etc.
In Workshops	CWM
Extra Divisional Units like Track Machine Organisation, XEN(B&F) etc	Concerned Depot Incharge with the approval of Concerned HOD

4. While deciding priority, the aspect of functional requirement of the post as well as availability of PwBD employee in feeder grade may be taken into account.

5. This has approval of the Competent Authority.
