In terms of Railway Board's letter No.2022/E&R/1(3)/5 dated 23/02/2024, Solapur & Pune Division of Central Railway with its revised jurisdiction as indicated below shall be functional w.e.f 01/04/2024.

- Para-4 of this office letter dated 01-04-02024 specified that option will be called from Running staff and their case will be dealt separately.
- Option from Running staff are now invited as follows:
- 3.1 From Non-gazetted running staff working in affected territorial jurisdiction i.e Manmad Jn. /Daund Jn. regarding their posting in either Pune Division or Solapur Division.
- 4. The terms and conditions of the transfer will be as under
- The seniority of staff who opt for Pune Division will be fixed on administrative ground and shall be determined in each grade on the basis of non fortuitous length of service in the grade as on 31-7-2024.
- Those who opt for Solapur Division, their lien will remain in Solapur Division and they will be considered for posting in 42 Solapur Division.
- 4.3 The staff will be transferred strictly as per seniority from amongst the optees of the parent Division for posts being transferred from Solapur Division to Pune Division.
- 4.4 After options are received, in the final list of transfer to Pune, 1st priority will be given to staff who have already registered their names for own request transfer to Pune Division. They will however go at bottom seniority as per rules of own request.
- Staff who opt for transfer should be in position ready for transfer on or before 31/08/2024. However, the mere fact of exercising option will not confer any right to the staff for his/her automatic transfer to Pune Division. Option will be considered only to the extent of post and ability to relieve by SUR Division.
- Any transfer to Pune Division after closure of this exercise will be treated as transfer on own request on bottom seniority in recruitment grade subject to usual conditions governing such transfers being filled.
- Sr. DPO/Solapur to call for the options to be exercised by all the running staff of affected territorial jurisdiction latest by 31/08/2024 in the prescribed format as Annexure- "A" and process accordingly. No option should be entertained if submitted after 31/08/2024
- Consolidated list of running staff along the option form and Service Resisters of staff who have opted for Pune Division 4.9 should be sent to Sr. DPO/PA latest by 15/09/2024 for taking them on roll of Pune Division. 4.10
- Lien should be fixed and seniority lists should be revised and published by Sr. DPO/PA latest by 31/10/2024.

Seniority lists should be revised and published by Sr. DPO/SUR too, latest by 31/10/2024 4.11
