Addendum & Corrigendum Slip (ACS) No. 1 to Standard Signages at Stations on Indian Railways, April 2023

1. **Signage Type F2 at Para 3.1 of Section -3:** Standard Types of Signages shall be read as under:



2. **Board Positioning and Board Type: Station Name Board (Tertiary) of Annexure C:** Signages for a Small/ Medium Size Station shall be read as under:

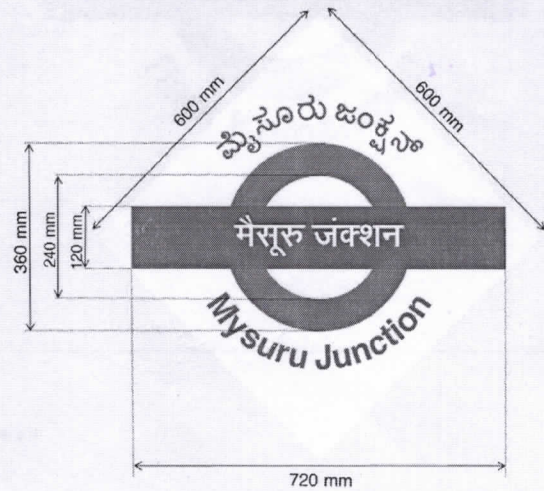
Station Name Board (Tertiary)

Type: F4

1. Square board of size 60 cm fixed with its diagonal axis in horizontal position. The central horizontal axis of the board should be at a height of 2m above the platform surface.

Red ring of outer dia 360 mm and inner dia 240 mm bisected centrally with Blue rectangular Band of 720 mm x 120 mm

2. Local Language on top, Hindi in middle and English at bottom in States located in Region B and C (in case Hindi is local language, only Hindi and English may be used)



3. Size of character text shall range from 35 mm to 75mm to accommodate the station name.

4. Number of Boards at Stations shall be such that at least one name board is visible from any compartment of a standing train but provided such that it is not conflicting with the natural movement of pedestrians.

5. The boards shall be either pole mounted, wall mounted or attached to Platform shelter stanchion. There shall be adequate back frame support to the Boards so that they are not easily vandalized or damaged.

6. Colour Scheme shall be as follow:

Red ring (CMYK: 0-100-0-100) bisected centrally with Blue rectangular Band (CMYK: 100-75-2-18)

Blue Text (CMYK: 100-75-2-18) on white background and White Text on Blue background.

7. Size of board can be appropriately increased up to 75 cm square if it is wall mounted and/or viewing distance from train is more. Consequently, other dimensions should be proportionately adjusted.
