

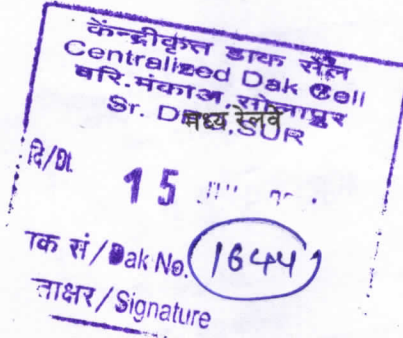

1. Vide letter at Ref, Pune Mandal had asked for a clarification that how the seniority of a JE who have been found successful against Rankers Quota/LDCE to be determined.

2. A reference regarding assigning of seniority of JE in Level-6 who were empanelled against LDCE/ Ranker quota was received vide letter 22.05.2024. The matter was examined in light of guidelines under Master Circular No.34 and Para 302 of chapter- III of IREM Vol-1. The relevant portion of IREM and Master circular No.34 is reproduced herewith for ready reference.

2.1 Chapter-III of IREM Vol.I Para 302 & Para 2.1 of Para 2 of Master Circular No.34 - Seniority in initial recruitment grades, it is specified that the seniority among the incumbents of a post in grade is governed by the date of appointment to the grade. In categories of post partially filled by direct recruitment and partially by promotion, the criterion for determination of seniority should be the date of regular promotion after due process in case of promotees and date of joining the working post after due process in the case of direct recruit, subject to maintenance of inter-se-seniority of promotee and direct recruits among themselves when the dates of entry into a grade of promoted railway servants and direct recruits are the same they should be put in alternate positions, the promotee being senior to the direct recruits, maintaining inter-se-seniority of each group.

2.2 In case the training period of a direct recruit is curtailed in the exigencies of service, the date of joining the working post in case of such a direct recruit shall be the date he would have normally come to a working post after completion of the prescribed period of training.

2.3 The provision contained in Para 2.1 above will also apply to the Inter Apprentices and departmentally selected candidates against the quotas prescribed in certain categories to be filled by LDCE.

2.4 While provisions under Para 303 of IREM are applicable to direct recruitment candidates, provisions of Para 302 are applicable for departmentally selected employees filled by LDCE quota also.

2.5 As per Master circular No. 34- Para 6 : Candidates selected for an appointment at an earlier selection shall be senior to those selected later irrespective of date of posting. (Para 306 of IREM).

2.6 Seniority of staff on promotion – Selection & Non-Selection posts, it is stated that in the case of selection posts, employees selected for empanelment should be arranged in the order of their seniority.

2.7 It is clear from the para 2.6 above that in selection posts the seniority should be maintained as per the empanelment i.e. as per seniority.

3. The seniority of staff promoted against LDCE quota should be regulated as per the panel position, subject to successful completion of training, wherever passing training is mandatory before they are posted on regular post.

3.1 The related disputes regarding seniority may be settled accordingly. If needed, Master Circular No.34 on "Seniority of non-gazetted staff" may be referred together with the related provisions under IREM Vol I for better appreciation.
