

NOTIFICATION**Sub:- Notification for admission in Sub-Hostel at Shivajinagar, Pune**

1. One of the Subsidized hostel of Central Railway is functioning at Pune for the benefit of Sons/Wards of Group "C" employees and erstwhile Group "D" Railway employees who have to send their sons/wards away from their official headquarters/ residence for the purpose of higher education. The hostel is intended for the sons/wards of Railway employees with accommodation for 38 students. Railway employees who are desirous to admit their sons/wards in the Subsidized Hostel for the academic year 2024-25 should submit their application in the prescribed form through their controlling Officers duly attested by them so as to reach the **Divisional Railway Manager(P)'s office, Welfare Section, Pune by 09.09.2024**. Applications received after 09.09.2024 or incomplete in respect of any details or submitted in forms other than that prescribed form by this office will not be considered. All these forms duly filled in by employees should be checked by the concerned incharge of the depot/ Division and verified by concerned Depot/Station welfare Inspector. No Column should be kept blank. The application should be submitted along with admission certificate, Bonafide certificate, last year passing mark list and recent medical fitness certificate. The applications not filled properly will not be accepted and no intimation for the same will be given.

2. The employees, whose sons/wards were already in the Hostel during the year 2023-24 and who desire to continue for the year 2024-25 for continuation of their already enrolled course should also submit their application in the prescribed form. Only those who have passed their last final examination shall be eligible for continuation in the Hostel.

3. The order of priority for admission will be as under:-

i. Students who want to continue in the Hostel to complete the course they were pursuing during the previous year, while staying in the hostel.

ii. Students studying up to XII standard.

iii. Students of Technical and Science courses like M.Sc, B. Sc, BE, ME, B.

Tech, M. Tech, Hotel Management, Technical Diploma etc.

iv. Students pursuing other courses in Arts, Humanities, Accountancy,

Commerce, Fashion designing etc. from recognized institutions.

4. Within these groups those who are securing admission for first time in the hostel will get priority over those who have already completed a course while staying in the hostel. Such students will not come under the category of continuing students.

5. **In the hostel, only the lodging facility (i.e only staying) will be provided.**

6. The Lodging charges payable by the employees whose sons/wards are admitted in the hostel as mentioned in Railway Board's letter No.E(W)2006-2/1 dated 07.07.2006(RBE 81/2006) will be recovered from the inmates, subject to revision, if any

7. For admission **First** priority will be given to the applicants of Pune division, **Second** priority to other division/ Units of Central Railway and still if any vacancies remains, the applicants of other railway will be considered on the basis of merit of each case.

8. Students who are in receipt of scholarship from Staff Benefit Fund and Tuition Fees from Railway will be admitted in the Subsidized Hostel only on payment of full rate and as per priority No.IV

9. The ward who is applying for admission in hostel should have passed his previous year's exam i.e 2023-24.

10. The ward who is applying for admission should have taken admission for higher education/Course.

11. The ward who is applying for admission, his education/ course should not be equivalent or lower to his previous year education/ course.

12. Only one son/ward of an employee will be considered for admission in a particular scholastic period.

13. The employees whose HQ or residence or both are within 25 kms from the Shivajinagar Hostel or the Institution/college where admission is sought will not be eligible for hostel admission. A declaration to this effect must be given by the applicant.

14. It will be the responsibility of the Railway employees themselves to secure admission for their sons/ wards in the Schools or Colleges before they are admitted in the Hostel.

15. Photograph of ward/dependent pasted on the application should be attested by Railway Officer /Controlling Depot Incharge.

16. Application should be verified by concerned Staff & Welfare Inspector of the Office/ Depot of the employee.

17. The final decision for allotment of hostel will rest with the administration.
