There will be daily proportionate reduction from the remuneration in the event of the CMP remains absent for period exceeding those stipulated in the contract.

The maximum age for first time engagement is 53 years and the age limit for re-engagements is 65 years or completion of 12 terms, which ever is earlier also each term of engagement shall not exceed more than one year as per Rly.Bd's L.No. 2018/Trans.Cell/Health/Medical Issues dt. 24/08/2018.

For Retired Government doctors, maximum age limit is 67 years and 07 terms. Retired Govt. Medical Officers of State Government and Central Government Doctors up to the age of 67 years may apply for CMP against existing regular vacancies on remuneration subject to the condition remuneration plus pension drawn by Retired government doctors should not exceed the last pay drawn.



#### **Educational / Professional Qualifications**

#### a) For Specialists i.e. Orthopaedic Surgeon, ENT, Dermatologist:

- 1. Degree in medicine i.e. MBBS recognized by the Medical Council of India.
- 2. Post Graduate qualification IDNB in the relevant subject field recognized by the Medical Council of India / State Medical Council.
- 3. Three years experience in Clinical work after Post graduation in the specialty concerned as on the date of interview is desirable.

#### b) For GDMO:

Degree in medicine i.e. MBBS recognized by the Medical Council of India.
 (Candidates must be registered with Medical Council of India / State Medical Council)

Candidates should have requisite academic qualification on the date of interview. Those who are appearing at and/or awaiting results of final examination are not eligible. Academic and Technical Qualification must be from a recognized Institution / Board. Otherwise candidature will be rejected. Candidates having higher qualification may also apply indicating the details.

The vacancies indicated may vary in number and place, depending on fresh sanctions received / resignations being given by existing candidates etc. Post indicated herein may be kept unfilled at the discretion of administration.

#### **Terms and condition**

#### (As per Rly.Bd. L.No.96/E(GR)II/9/16 dated 23/02/2000)

- The contact shall be for one year or less from the date of entering into contract. Period of contract is not extendable on any grounds. However, Railway administration shall reserve the right to enter in to fresh contract with the Medical Practitioner for another term.
- 2. The full time contracted Medical Practitioner (hereinafter referred to as <u>CMP</u>) who enters into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract.
- 3. CMP can terminate the contract by giving a 15 days notice. Administration can also terminate a CMP by issuing 15 days notice. However in exceptional circumstances due to exigencies of service and administrative interest a CMP may be terminated with immediate effect without assigning any reasons whatsoever. Contract shall also be terminated if the CMP is found to be mentally or physically incapacitated.
- 4. The CMP shall undergo a Medical Examination before entering into contract. The CMP shall have to undergo a brief orientation for a period of two weeks.
- At the time of entering into contract the CMP shall produce certificate of his/her character and antecedents from two gazetted officers of Central / State Government .
- 6. Normally Sundays and National Holidays will be off and in addition, authorized absence without detriment of the terms shall be allowed at the rate of two days per month to be availed any time during the contract to the extent earned by the CMP till such time. This facility will be available subject to the CMP fulfilling the conditions stipulated in clause 8 and 9 of the terms & conditions below. Any CMP leaving his place of work on leave of absence / National Holidays/Sundays should get prior permission of the controlling authority.
- 7. The CMP may avail of free medical treatment for self only except the operations categorized as "Special" in para 622 (8) of Indian Railway Medical Manual 2000 and treatment normally available at super specially centres from his/her respective railway hospital during the currency of contract.
- 8. The CMP shall be governed in respect of matters not referred to in these terms and conditions by any orders amendments to the terms of contract issued by the Railways from time to time.
- 9. The CMP shall attend to all normal tasks, which any medical practitioner is conventionally doing including duties in Casualty, ICU & OT. CMP duties also include attending station and train emergency calls and accidents. Among those above, appropriate duty list would be provided by CMS at the time of appointment. CMP should he remaining available to attend emergencies if any at all times.

- 10. The CMP shall issue sick/fitness/duty certificates for a period up to 7 days , beyond which the certificate so issued by him / her should be countersigned by a regular Railway Medical Officer available at the nearest Hospital/Dispensary/Health Unit .
- 11. The CMP shall not perform administrative work like pre employment or periodical medical examination sanction of leave to Group 'C' and 'D' staff and certification with respect to food items considered unfit for human consumption etc. However, the CMP shall be allowed to permit Group 'C' and 'D' staff Casual Leave, if sought for 03 days or less at a stretch.
- 12. The CMP shall not make medical recommendation of any kind referred to Para 559 to 564 of Indian Railway Medical Manual (IRMM) 2000.
- 13. The CMP will not have any financial powers; however, he / she may operate the imprest account in accordance with the guidelines contained in the IRMM. However, the cash vouchers in such cases shall be got countersigned by an authorized Railway Medical Officer. No cash imprest account shall be recouped unless the proposal is countersigned by an Indian Railway Health Service Officer.
- 14. The CMP shall not initiate/review/accept the annual confidential reports of Group "C" railway employees. However, he/she shall, on request, prepare and present the performance report of the staff.
- 15. The CMP shall not indent or condemn/recommend for condemnation of any tools and plant.
- 16. The CMP selected should not perform / involve in any activities that would be considered against the interest of Medical Department Railways, and if found, his/her services will be terminated immediately.
- 17. Consolidated remuneration as per instructions issued by Railway Board time to time will be payable to the CMPs. There will be daily proportionate reduction from the remuneration in the event of the CMP remains absent for period exceeding those stipulated in the contract.
- 18. Expenses on outstation journeys connected with the duties/ works will be borne by the Railway. Duty passes will be issued by the Railways for the purpose of journey in the line jurisdiction of the Health Unit where the CMP renders service and to the Divisional Headquarters and the CMP will be paid a fixed rate of Daily Allowance @ Rs 900/- (Rupees Nine hundred) per day during such journeys. This will be subject to fulfilment of other provisions pertaining to Daily Allowance prescribed in IREC Vol II as per Rly.Bd.L.No. 2014/E(GR) II/1/1 dt. 19/12/2018.
- 19. The CMP shall also not be entitled to any benefit like Pension, Gratuity, Seniority , Promotion etc. or any other benefits available to Railway Officers appointed through UPSC
- 20. The CMP may be given one set of First Class complimentary pass for self and family during each contract. The pass, however, shall be issued after he/ she renders three months of contracted service regularly.
- 21. No Railway Privilege passes/PTOs shall be admissible to Retired Railway Doctors engaged as CMP's in his/her capacity as CMP.

#### NOTE:

Doctors serving under State/Central Govt/ Public sector undertaking etc. may apply with NOC from the respective organization.

Doctors while applying should indicate past service rendered, if any including the period of contract put in by them on all over Indian Railways.

No accommodation/Pass/PTO will be provided to applicants.
