Applications in the prescribed Proforma are called from the employees belonging to the following categories:

- 1) Volunteers from Track Maintainers of all grades, Civil Engineering Department, SUR Division & Track Maintainers in all grades whose seniority is mentioned in the Seniority unit of SUR Division.
- 2) Volunteers from the employees belong to categories of USFD staff, Blacksmith, Hammer man, Welder, Molder, Aligner, Painter, Carpenter etc. working on P. Way side, with 03 years of Railway service who are in the Level of below 06.
- 3) Artisan Helpers presently working in P. Way cadre and who have experience of working in P Way side for three (3) years, provided they fulfill educational qualification and other eligibility criteria for the post.

4) Eligibility Conditions:

- a) Volunteers should be in the Level below 06.
- b) They should have completed 03 years regular service in P. Way side on the date of notification.
- c) Volunteers should be in the age of below 47 years for General Category (UR) employees and below 52 years with relaxation of 5 years for SC/ST employees as on the date of the notification.
- d) Three years regular service will not include the 03 years training period for the candidates appointed as Tech-III in the artisan categories.

5) Education Qualification:

They should have educational qualification of 10+2 pass with at least three subjects out of Mathematics, Physics, Chemistry and Computer Science or having Diploma in Civil Engineering / Civil Engineering (Transportation) are eligible. All Diplomas should have the recognition / affiliation of AICTE. They should possess the educational qualifications on date of notification.

<u>Selection Procedure:</u> The selection comprises of written test either through "CBT OMR or Pen & Paper" Mode depending on availability. The Question paper will be 100 Objective Type. 10 optional questions pertaining to Rajbhasha in terms of RBE. No. 196/2018 dtd. 14.12.2018. The duration of written examination is 02 hours in terms of RBE No. 97/2019 (Total 110 questions i.e. 100 questions+10 optional Rajbhasha for 2 hours). All the questions will be multiple choice only.

As per RBE No. 196/2018 dated 14/12/2018, cutting, overwriting, erasing or alteration of any type in the answer will not be accepted. Zero mark will be given for the answer having correction/overwriting. There shall be negative marking for incorrect answer. One third of the marks allowed for each question will be deducted for wrong answer.

Scheme of Examination: The scheme of selection comprises of Written Examination only. Those who have secure 60% marks and above in the written examination will alone be considered for further empanelment process of the securing of 60% in aggregaste i.e. written test and record of service is the criteria for placing on the panel subject to the extent of vacancy notified. Empanelment is purely on the basis merit and medical exam in A-3 (Aye-Three) standard. There is no relaxation for employees belonging to the reserved community since the post is classified as safety post.

The Written Examination for the above Selection will be held on 10/11/2024 the venue of the return test(CBT) will be informed in due course.

Depot In charge leave of any kind not to be granted to the employees on the date of written test. instructions to the candidates to be strictly followed during the written test:

Cell phone, any electronic gadget if found in possession of candidate he will be debarred.
- 2. Candidates can use blue/black ball point pen only. Gel Pen /Pencil or ball point pen with other colors such as red, pink green etc. o highlighters and sketch pens are not allowed. Do not put stray marks anywhere on the OMR Sheets.

- b) As per Railway Board;s Letter no. E(NG)I-2023/E(NG)I/9 dated 08.06.2023, total marks secured by all the candidates who have been evaluated after qualifying the written examination and the marks secured in the written test in case of the remaining candidates will be uploaded in Rail Net website http://cr.indianrailways.gov.in/ after finalization of the panel.
- c) As per Railway Board's letter No.2010/E(RRB)/25/27/Pt. dated 09.06.20211 stipulates that wherever any question(s) in the question paper(s) is found to be incorrect, the question(s) may be omitted from the scope of evaluation instead of giving grace mark(s) and raw score may be assessed on percentage basis.

Accordingly, in terms of Railway Board vide letter No.(E(NG) I/2018/PM1/4 dated 07.11.2023, In case some of the question(s)/answer therein are incorrect, the procedure as prescribed in above Railway Board's letter dated 09.06.2011 will be adopted only for those candidates who have attempted that/those incorrect question or questions with wrong answer(s). This will be applicable to question paper(s) involving optional question(s).

Notifying to the staff:
