It is proposed to conduct the Selection for the post of JE/Works in Matrix Level-6 against 15% LDCE quota in Civil Engineering Department of Solapur Division.

1) Eligibility conditions to volunteer for the selection:-

- vi) Staff eligible for the selection: Staff should be from the category of skilled grades in Works Branch and Artisan (Helper) in Level-1 working in works cadre having experience of 3 years. Training period will not be counted towards the minimum 03 (three) years period except technical qualification and have undergone 06 months training. Those who are working in an ex-cadre post but have a lien at Technician/Civil Engineering Department will be eligible, provided they satisfy the other conditions.
- vii) Length of Service: Should have been working on the works side and have completed 03 years of Railway service as skilled grades in Works Branch as on notification.
- viii) Educational qualifications: Should be should be in possession of educational qualification of ITI/Act apprenticeship pass or 10+2 in Science Stream RBE 93/2022) or its equivalent with any of the Science subjects (or) Degree or Diploma in Civil Engineering or its sub stream (Educational qualifications must be counted as per Service Register).
- ix) Age: Should be below 47 years for General Category (UR) employees and below 52 years with relaxation of 5 years for SC/ST employees (RBE. 92/2023 Dtd. 18.07.2023) as on the date of the notification.
- x) Application are therefore invited in the prescribed format enclosed as **Annexure-A** from the eligible regular employees working in works wing of Civil department who fulfils the eligibility criteria as prescribed in this Notification including age and educational qualification.

2)Procedure for written examination:-

v) The selection process consists of written exam of 100 marks question by perusal of Service records and medical exam in B-I (Bee One) standard. Only those employees who qualify in the written test will be considered for subsequent stages of the selection. The panel will be declared purely in the order of the merit on aggregate only. No relaxation for SC/ST employees as this is a safety category.

- vi) The Question paper will be 100 Objective Type.10 optional questions pertaining to Rajbhasha option basis (Total 110 questions i.e. 100 questions+10 optional Rajbhasha for 2 hours). All the questions will be multiple choices only. Employees should attempt 100 questions will be evaluated.
- vii) There shall be negative marking for each incorrect answers, 1/3 of marks allotted for each question will be deducted for wrong answer as per Rly. Bd's lr. No. E(NG)I/2018/PM1/4 dtd.14.11.2019 RBE No. 194/2019.

viii) The selection comprises of written test either through "CBT OMR or Pen & Paper" Mode depending on availability.

- v) As per RBE No. 196/2018 dated 14/12/2018, cutting, overwriting, erasing or alteration of any type in the answer will not be accepted. Zero mark will be given for the answer having correction/overwriting. There shall be negative marking for incorrect answer. One third of the marks allowed for each question will be deducted for wrong answer. The written examination will be conducted on OMR sheet. Answering should be done by way of bubbling in supplied OMR sheet with ball point pen only (No gel pen is allowed).
- vi) To ensure authenticity of the answers, cutting, over-writing, erasing or alterations, double bubbling of any type in the answer will be considered as wrong answer and negative marks will be deducted.
- viii) The question paper will be in English & Hindi languages only.

3)Scheme of Examination: The scheme of selection comprises of Written Examination only. Those who have secure 60% marks and above in the written examination will alone be considered for further empanelment process of the securing of 60% in aggregate i.e. written test and record of service is the criteria for placing on the panel subject to the extent of vacancy notified. Empanelment is purely on the basis of merit. There is no relaxation for employees belonging to the reserved community since the post is classified as safety post.

The Written Examination for the above Selection will be held on 10/11/2024 the venue of the return test(CBT) will be informed in due course.

The staff concerned may be advised regarding the above Selection accordingly, the employee

should report on the date without fail with the proper bearer letter

along with photograph duly attested by the Controlling Officer. Depot In charge leave of any kind not to be granted to the employees on the date of written test. If any employee is on leave sick list he should be specifically informed regarding the above test at his address by deputing a special messenger and acknowledgement obtained in writing.

" After last entry time no candidates will be allowed in the examination hall."

The employee who remained absent on written test will be allowed in Supplementary Written Test with valid reasons (if under Sick of Railway Doctor). The concerned Officer/Incharge should ensure that all the eligible employees are directed for written test on date in time and with proper bearer letter.

ready reference.

4)Pre-Selection Training (PPT):

- e) Branch officer shall arrange for Pre-selection coaching to the eligible reserved category employees for the period of 3-4 weeks (21working days), training must cover the Syllabus of the exam to be conducted. Pre selection coaching will be imparted at the nominated training centers or any other method. The schedule for which will be notified separately.
- f) the nominated training centers or any other method.
- g) After completion of Pre-selection training, a certificate is to be issued by the controlling officer to the effect that all eligible SC/ST employees have been imparted Pre-selection training for a period of 21 working days.
- h) In case any reserved category employee is unwilling to undergo PPT then, a written undertaking in this regard shall be obtained and sent to this office.

5]Additional information for guidance to the staff: In terms of this office letter No. SUR/P//Con/Selection/ Publishing Answer-Key/2023 dated. 22.11.2023 it is hereby advised to incorporate the following instructions/clarification issued for all departmental /LDCE selection.

- d) As per HQ letter No. P/HQ/Ruling /0/803 dated.07.10.2022 the 'Answer key' if any will be upload in Rail Net website or 'Revised Answer Key' http://cr.indianrailways.gov.in/ any representation(s) against the questions/ options, to be uploaded by the examines with proper clarification (only candidate who appeared) on email id (srdposur@gmail.com) only (not through DAK) and the examinees will be given only 07 days (including intervening holidays) from the day next to date of publishing of Answer key.
- e) As per Railway Board; Letter no. E(NG)I-2023/E(NG)I/9 dated 08.06.2023, total marks secured by all the candidates who have been evaluated after qualifying the written examination and the marks secured in the written test in case of the candidates will be uploaded Rail Net remaining website http://cr.indianrailways.gov.in/ after finalization of the panel.
- f) As per Railway Board's letter No.2010/E(RRB)/25/27/Pt. dated 09.06.20211 stipulates that wherever any question(s) in the question paper(s) is found to be incorrect, the question(s) may be omitted from the scope of evaluation instead of giving grace mark(s) and raw score may be assessed on percentage basis.

Accordingly, in terms of Railway Board vide letter No.(E(NG) I/2018/PM1/4 dated 07.11.2023, In case some of the question(s)/answer therein are incorrect, the procedure as

prescribed in above Railway Board's letter dated 09.06.2011 will be adopted only for those candidates who have attempted that/those incorrect question or questions with wrong answer(s). This will be applicable to question paper(s) involving optional question(s).

6)Notifying to the staff:

The controlling officer/supervisor shall give wide publicity of the notification to all the eligible staff of Engg. Department of SUR Division and notification should be displayed at notice boards and conspicuous place. It is the responsibility of controlling officer/supervisor to

circulate the notification among the staff concerned.

In terms of Railway Board's letter No. E(NG)I-72/PM1/166, dated 26.06.1972, the Senior Subordinate/Supervisor concerned has to furnish a certificate that the eligible candidates were duly notified of the holding of the test and asked to submit their applications duly giving their willingness" and forward the same to DRM(P)SUR. It should be the personal responsibility of the Senior Subordinate/Supervisor to complete the formality in this respect. It is further advised that any other communication received in respect of the selection should invariably be intimated to all the eligible employees. In case of non receipt of any communication the same may be obtained from the Personnel department or from the Controlling Officer. Any laxity in this regard will be viewed seriously.

7)The syllabus for the Written examination is enclosed as Annexure "B"

8) The panel will be format strictly in order of merit from amongst all the employees who are adjudged suitable by the committee, to the extent of vacancies notified duly observing reservations.

9)The volunteers should be in readiness to appear for the written exam at a short notice

treating this notification as alert notice.

10) Willing employees who fulfils the above eligibility conditions may submit their application in the proforma Annexure "A" on or before 03/09/2024 to their respective depot in charges who may forward the fresh applications duly verified to DRM (P) SUR before 04.09.2024. Even if no application is received from the employees by the cut-off date i.e. 03/09/2024, a "NIL" report should be furnished to this office by ADENs concerned, all ADENs may strictly advised that to submit the applications DRM (P) SUR in one lot, scattered applications could not be accepted so as to avoid back references.

11) Applications received from the employees directly at Sr.DPO's Office/ incomplete applications/ applications received without certification by the concern Depot In-charge with ADENs Office /applications received the due date and also without copies of education Technical qualification certificates will be summarily rejected without further notice.

12) Those who are eventually considered for the posts as JE (Wks) have to undergo 12 months training. During the period of training, they will enjoy the same privilege and status of category from which they are selected or to fix their pay on the stipendiary scale. There will be no supplementary written examination for the above post.

13) The notification is provisional and subject to the outcome of any court case pending before. Any Court of law regarding reservation matters.

14) The notification should be given wide publicity for information of all the employees concerned. Employees may visit Solapur Division website Notification is also published on Web page on address <u>cr.indianrailways.gov.in/about us/division/Solapur/personnel.</u>

16) There will be no supplementary written test.

2)Railway Board vide letter dated 10/09/2014 have instructed that wherever the vacancies remain unfilled in promotion quota the same will be carried forward to LDCE/GDCE quota if any and the unfilled vacancies of LDCE/GDCE will be carried forward to direct recruitment quota to next year selection. In case there is no LDCE/GDCE for the post the unfilled vacancies may be diverted to direct recruitment quota of the upcoming year.

3) As per HQ'rs letter dated 12/06/2024, the earlier Notification dated 13.03.2024 issued for the selection of JE(Works) against 15% LDCE Quota is treated as cancelled.
