NOTIFICATION

Sub: - Selection for the unified post of Chief Loco Inspector in Pay Matrix Level-7 of 7th CPC in Loco Running Department of Solapur Division.

Ref: - 1) RB's letter No E (P&A) II-2009/RS-17 dated 03/07/2019 (RBE No 108/2019)
2) RB's letter No E (P&A) II-2009/RS-17 (Vol.II) dated 01/11/2021 (RBE No 80/2021)

It is proposed to conduct a selection for the unified post of Chief Loco Inspector in Pay Matrix Level-7 of 7th CPC in Loco Running Department of Solapur Division. Applications are invited from eligible volunteers in Loco Running Department.

In terms of Boards letter dated 03/07/2019 (RBE No 108/2019) & dated 01/11/2021 (RBE 80/2021), notification for filling up the post of Chief Loco Inspector is issued as under-.

Eligibility conditions:-

- 1) Employees working as Loco Pilot (M/Exp), Loco Pilot (Passenger) and Loco Pilot (Goods) who have completed 5 lakh kilometers of actual footplate duties (actual footplate duties have been defined in Board's letter No E(P&A)/II/2007/EA/14 dated 12/02/2015) as Loco Pilots or have completed 10 years of actual service as Loco Pilots, whichever is earlier, would be eligible for selection. Drafted Loco Pilots working as CC, PRC and TLC on date can also apply for the selection provided they fulfill the eligibility criteria.
- 1) The Medical standard for selection to the post of CLIs should conform to the existing medical standards of A-3 (Aye three)
- 2) Medically de-categorized Loco Pilots up to the medical standards of A-3 (Aye three) and also possessing the driving experience as per Para above would be eligible to apply for the selection in terms of Boards letter No E(P&A)/II/2006/RA-21 dated 03/01/2007.
- 3) The eligibility criteria should be fulfilled as on date of issue of notification i. e. 04/08/2023

Assessment of vacancies:

UR - 12, SC - 04, ST- 02 Total = 18

Selection:-

Options from eligible and willing employees working as Loco Pilot (M/Exp), Loco Pilot (Passenger) and Loco Pilot (Goods) will be called for filling of the post of CLIs.

In terms of RBE No. 161/2009 dated 03/09/2009, the post of Loco Inspector is classified as General Selection. Railway Board vide RBE No. 80/2021 dated 01/11/2021, has instructed to follow the selection procedure for promotion to General Selection post in the case of selection for CLIs post as well.

In terms Para 3 of RBE No 113/2009 dated 19/06/2009, in cases of promotion to General posts in which candidates are called from different categories, whether in the same department or from different departments and where zone of consideration, is not confined to three times the



number of staff to be empanelled, panels should be strictly prepared as per merit, with reference to marks obtained by the candidates in 'Professional ability' and 'Record of Service', subject to usual relaxation for SC/ST staff, wherever permissible, those securing less than 60% in 'Professional ability' and 60% in aggregate, will not be considered for inclusion in the panel. Further, the service records of only those candidates who secure a minimum of 60% marks in 'Professional ability,' shall be assessed. Since final panel has to be drawn on the basis of merit, there will be no scope for erstwhile provision of placement of candidates who secure 80% or more marks, classified as 'outstanding', on the top of the panel.

Written Examination:-

As per Boards letter No. E (NG) I/2018/PM1/4 dated 14.12.2018(RBE 196/2018), circulated under PCPO/CSTMs letter No P/HQ/Ruling/O/803 dated 19/12/2018, the question paper will henceforth be 100% objective type. All the questions will be of multiple choice only. Zero marks will be given for answer having correction/over writing. 10% marks will be on Rajbhasha (Official Language Policy) which will be optional. The examination will be conducted on OMR sheet or CBT. In terms of Boards letter No E(NG)I/2018/PM1/4 dated 14.11.2019 (RBE 194/2019)circulated under PCPO/CSTMs letter No P/HQ/Ruling/O/803 dated 28/11/2019, there will be negative marking @ 1/3 mark for a wrong answer.

Syllabus & Question Bank:- The syllabus and question bank for selection will be circulated later.

Pre- Selection Training:- After publication of list of eligible candidates, pre selection coaching to eligible SC/ST employees will be imparted as per the syllabus for a period of 3 to 4 weeks.

There will be no supplementary written examination.

Since the selection is conducted by calling applications from eligible volunteers, the Loco Pilots who are selected for the post of Chief Loco Inspector will not have option for repatriation to their parent cadre.

The CLIs who are working as Instructor at ZRTI/BSL, if repatriated to SUR Division, then the Junior most CLI working on SUR Division will be repatriated to his parent cadre i.e. Loco Pilot.

Please give wide publicity to this Notification amongst all the staff, working under your control and exhibit one copy of Notification on the Notice Board. While receiving the applications from the staff, it should be ensured that the application is complete in all respects and necessary certificate in support of date of birth, educational qualification and Caste Certificates are attached..


