
Sub: Imposition of Ban on Sick Leave Based on Private Doctor's Certificate

In recent times, it has been observed that Loco Running staff are frequently reporting sick on the basis of private doctor's certificates, often without valid reasons and resuming duties after a brief period of 2-3 days. Given the current vacancy situation in the Loco Running cadre, the availability of adequate Running staff is crucial for the smooth operation of train services.

In view of the above, it is proposed that the submission of sick leave requests based on private doctor's certificates be temporarily suspended with immediate effect, until 10th November 2024.

Furthermore, it is requested that no Special Casual Leave be granted to Loco Running staff for Union meetings, cultural events, Scout & Guide activities, sports meets or similar events, without prior approval from the undersigned. Prior sanction for Special CL should henceforth be obtained from the undersigned before approval is granted.

Please initiate the necessary actions and issue the appropriate instructions immediately.
