Sub: Formation of panel for filling up the post of Jr. Clerk-cum-Typist (Personnel) in Pay Matrix Level-2 against 331/3% DPQ for Solapur Division/CR.

It is proposed to form a panel for filling up of 04 (four) posts of Jr. Clerk-cum-Typist in Personnel Department in Pay Matrix Level-2 against 331/3% DPQ quota of Solapur Division (By calling option).

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:

- a. 2(Two) years service is mandatory for all the employees. In computing the qualifying service, the temporary service before regularization will also be taken into account. (Rly. Bd's L. No. E(NG)I-2015/CFP/8 dated 21.04.2017.
- b. Regular employees serving as Peon (Office Assistant/ Genl. Assistant), Record Sorter, Daftary, Jamadar, Hamal, Mali etc. and who do not have regular channel of promotion and have minimum 02 year continuous service, on the date of issue of Notification are eligible for the selection.
- c. Those employee coming under the Administrative control of DRM, Solapur having no other channel of promotion and who are confirmed on the date of notification and who were engaged as a Substitutes (other than CDMH/EH/Bungalow Peon) having 02 years service/residency period, countable from the date of temporary status and for initially engaged Substitute CDHM/EH/Bungalow Peon treated regular from the date of screening and two years probation period, will be eligible in terms of instruction issued vide Rly. Bd's L. No. E(NG)I-2015/CFP/8 dated 21.04.2017. For employees initially engaged as a Substitute CDMH/EH/Bungalow Peon, the benefit of screening shall be extended after three years from the date of grant of temporary status.
- d. Those staff who have come on own request transfer, the service rendered in the old unit will count for the purpose of qualification for promotion, provided the category in which he/she was working in the old unit is an eligible category for the selection post in the new unit. As per Rly. Bd's L No. E(NG)/I/2006/CFP/9 dated 27.07.2006 and L. No. (NG)I-2006/PM/5 dated 21.03.2006.

e. Only erstwhile Gr. 'D' staff who have transferred from Solapur open line division and working on construction, RE organization or elsewhere and still holding lien on Solapur division are eligible to apply. The staff not coming under the 'Administrative controls of DRM/SUR are not eligible to apply, i.e. RPF department. Account department, W/Shop and Track Machine Organization etc.

2. EDUCATIONAL QUALIFICATION:-

Candidate should have knowledge of reading and writing in English and Hindi.

4. PROCEDURE FOR WRITTEN EAMINATION:

- a. The exam will be held in OMR Based.
- b. Question paper will be 100% objective type.
- c. All the questions will be of multiple choices only.
- d. There will be no negative marking for incorrect Answer. Each correct answer will fetch 1(one) mark and no credit will be given to un attempted question and wrong answers.
- e. Cutting, Overwriting, erasing or alteration of any type in the answers will not be accepted zero mark will be given for answer having correction /overwriting.
- f. There will be 110 questions including 10 optional questions on official language policy and candidates will have to answer 100 questions only. If any candidate answers more than 100 questions, the first 100 attempted questions will be counted.
- g. The above selection is against Departmental Quota and panel is required to be drawn in the order of their seniority amongst the qualified staff as per the provisions of Para 189 of IREM. The panel will be drawn after scrutiny of Service Record and last 03 (Three) years APAR's of the staff those who qualified in the written examination test.
- h. The duration of examination under objective type multiple choices will be 120 minutes.
- i. No supplementary test will be held being general selection post.

5. TYPING TEST:

The empanelled candidates for promotion to the post of Jr. Clerk-cum-Typist will be required to pass Typing Speed Test. The above Typing speed should be conducted in terms of Rly. Bd's L. No. E(NG)I-2015/CFP/8 dated 04.02.2011 & Rly. Bd's L. No. E(NG)I-2015/CFP/7 dated 16.01.2017 & 11.01.2023. However, the above promotion may be allowed on provisional basis and the staff concerned will be given (two) years time from the effective date of promotion to qualify the prescribed Typewriting test. If they fail to qualify in typewriting test within the said period they will be liable to reverted and till such time their promotion will be provisional basis.

6. SYLLABUS:-

- a. To test the working knowledge of Railway employees in English and Hindi language.(IREM Para-189 & HQ L. No. P/HQ/Ruling/O/803 dt. 13.11.2017.
- b. General standard in intelligence proficiency in Arithmetic, General knowledge pertaining to Railway matter and matter immediately pertaining to the work of employees have been acquainted with during his/her Railway service.

7. FORMATION OF PANEL:-

Against 33 1/3% department quota panel shall be drawn in the order of seniority amongst the qualified employees taking in a account the notified vacancies.

8. PROVISION OF RESERVATION:

Reservation policy of SC/ST will be applicable as per Rly Bd's L.No.2018-E(SCT)1/25/9 dated 05.01.2023 Rly Bd's L No.2018-E(SCT)I/25/9 dated 22.06.2022 & Rly. Bd's L. No. 2018-E(SCT)I/25/9 dated 13.04.2022 & dated02.05.2022 and HQ L.No. P/CR/HQ/RP/601-Policy dated 05.8.2022.

9. DATE OF EXAMINATION AND VENUE:

The date, venue and time of examination will be intimated in due course. However, it is to be advised to the volunteering staff that there will be no supplementary examination for the absentees being.

10. LAST DATE OF SUBMISSION OF APPLICATION:

The willing employees having fulfilled the eligibility criteria may send their application as per enclosed proforma (Annexure-A) along with self-attested photocopy of educational qualification, caste certificate, disability certificate (if any) and other necessary documents to their controlling officers by 06.08.2024. Concerned controlling officer should duly check & verify all columns of the applications affixing his signature with stamp and sent all the applications in a bunch along with testimonial to Sr. DPO's Office on or before 08.08.2024 positively. Application will not be directly received in this office. After the 08.08.2024 (last date), no application will be entertained. Staff working in Construction/Project/ Ex. Cadre organization/units etc. and maintain lien in Solapur Division should submit their application within a time. Their eligibility will be determined with reference to condition laid down, position in parent.

11. NOTIFYING TO THE STAFF:

Wide publicity of this notification should be given amongst the all eligible staff. A copy of notification should be displayed on a notice board at a conspicuous place. Staff who is on deputation/leave/sick should also be notified to enable them to submit their applications in time.
