1	The retired Officers will be re-engagement against the vacant posts at JTS (Level-10) & STS (Level-11) as Consultants(Department Trade Name as per list of post enclosed).
2	All works/duties attached to post and day to day work as directed by Controlling Officer would be the responsibility. AS PER THE JUSTIFICATION
4	They will not sign on behalf of President of India in any contract, agreement and will not represent the Railways in any meetings.
5	Such re-engaged retired officers will not be part of any selection committee/tender committees. They will not certify Measurement Book or certify any document.
6	The re-engaged retired officers will not handle Confidential/Secret papers/Assignments.
7	Suitability/Competency of the retired officer will be adjudged before such re-engagement by a committee of three PHOD/CHOD/SAG officers as appointed by GM.
8	While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing provisions.
