Sub: Concessional Permissible Carrying Capacity(PCC) of Wagons- Steel Pipes.

- Reference above, Concessional Permissible Carrying Capacity(PCC) and Loading Tolerance on various routes for "BOST" type of wagons (at S.No. 26 in Annexure-IA under category A. OPEN WAGONS) when used for carrying "Steel Pipes" is as under:
