You may recall that CRB & CEO vide his D.O. letter of even no. dated 09.10.2024 had prescribed certain action points, in view of the specific directions given by Hon'ble Prime Minister in one of the cabinet meetings.

- Parallelly, National Learning Week (NLW) an initiative to inspire and energize civil servants towards achieving a culture of continuous learning and capacity building was also launched.
- It is heartening to note that Railways have proactively responded to and demonstrated remarkable progress, which is evident from the following table:

- While I appreciate all the Railway MDOs for the progress shown, the following core targets/mandates set forth are yet to be achieved by IR:
 - a) 100% onboarding of IR officials on iGOT Karmayogi Platform.
 - b) 100% completion of Prarambh module by railway rozgar mela appointees.
 - c) 6-hour iGOT learning by each on-boarded officials.
- Besides, availability of railway related courses also need to be increased significantly. Presently, merely 51 courses out of about 1500+ courses available on IGOT platform are railway related.

I, therefore, request you to monitor closely the Mission Karmayogi compliance for your Railway in order to achieve the targets/ mandates set forth.
