Written test held on **07.02.2025**.

The examinees (only candidates who appeared) of the corresponding exams will be given only 7 days (including intervening holidays) from the day next to date of publishing of keys in website i.e. from **08.02.2025** to **14.02.2025** to send a written representation with respect to keys and ambiguity in questions to respective Personal branch Officer on the notified email id after obtaining endorsement of their controlling officer certifying the identity of the examinee raising the objection.
2. No further time will be given under any circumstances for the exercise.
3. While sending the representation, through email the examinee should attached the authority on the basis of which the examinee has raised the objections, without which the representation will not be considered.
4. The decision of the paper setting authority after this exercise will be final and no further correspondence in this regard will be entertained.
5. The final keys along with decision taken on the representation reviewed will be published in the Rail net within the period of 03 working days after completion of 07 days.
6. Decision of the competent authority in case of discounting of any questions or otherwise on account of incorrect wording of questions or all answers are wrong situations will also be communicated along with publishing of final keys.
