ADVANCE RATE NOTIFICATION NO. 11 of 2025(GOODS)

Sub: Running of freight trains on CC+8 tonne routes.
(C/533/GR-I/2020/0/I)

1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Managers are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
3. Eastern Railway has forwarded proposal with due approval of General Manager to include routes in the list of already identified CC+8 routes as below:

1. MURSHIDABAD- AZIMGANG Jn (MBB-AZ) S/L Section
2. BELANAGAR- DANKUNI(BZL- DKAE) (UP Chord, DN Chord & Rev. Chord) Section
3. BALLY CHORD – BELANAGAR (BLYC- BZL) (UP HBC, DN HBC 1 & DN HBC2)Section
4. SHRIRAMPUR – SHEORAPHULLY (SRP-SHE) (UP ML, DN ML, Rev.Line

4. Sanction of the Competent Authority is hereby accorded to include the above referred routes of Eastern Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 60 kmph. This speed limit shall be reviewed by the Zonal Railway and may be revised as and when required.
5. Further, Zonal Railway shall ensure compliance of all guidelines stipulated in RDSO's L.No. CBS/Golden/Q/Strength dated 25.09.2009& 21.07.2009 and in Para No. 212A of IRBM (Indian Railway Bridge Manual). Observance of all speed restrictions mentioned in Bridge Certificates. Completion of ongoing Bridge works required for operation of CC+8t loading at proposed speed.
6. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
7. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.

8. These instructions shall come into effect from 20.02.2025 and shall remain valid till further advice.

9. This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
