Applications are invited from eligible staff of Indian Railways for selection to the 02 (Two) 'ex-cadre' post of Chief Vigilance Inspector (Engg.) in Matrix Level-7 (7th PC). 02 (Two) 'ex-cadre' post of Chief Vigilance Inspector (Elect.) in Matrix Level-7 (7th PC), 02 (Two) 'ex-cadre' post of Chief Vigilance Inspector (stores) in Matrix Level-7 (7th PC) and 01 (One) 'ex-cadre' post of Chief Vigilance Inspector (IT) in Matrix Level-8 (7th PC), 01 (One) 'ex-cadre' post of Chief Vigilance Inspector (Mech.) in Matrix Level-7 (7th PC), 01 (One) 'ex-cadre' post of Chief Vigilance Inspector (Accts) in Matrix Level-8 (7th PC) and 01 (One) 'ex-cadre' post of Chief Vigilance Inspector (Pers) in Matrix Level-7 (7th PC) and 01 (One) 'ex-cadre' post of Chief Vigilance Inspector (S&T) in Matrix Level-7 (7th PC) on tenure basis, for working in Vigilance department of Central Railway, CSMT, Mumbai.

The normal period of tenure of the post is 3 (Three) years, which could be extended for further period upto 2(Two) years, if so required by the department. On completion of the tenure, the staff would be repatriated to the respective parent cadre on the Railway, where he/she holds lien. However, the staff selected for the post could be repatriated at any time, on or before completion of the tenure without assigning any reason whatsoever.

# Selection Process: -

In terms of Indian Railway Vigilance Manual (IRVM)-2018, Chapter-VIII, Para.821.5 the normal establishment rules applicable to regular selection posts need not to be applied in the

A written examination and a Vigilance Aptitude and computer knowledge test will be conducted as part of selection procedure with following eligibility criteria: -

### [1] Eligibility:-

The staff should have sound integrity, should not be figuring in any current Vigilance/SPE/DAR case and should not have been imposed any major/minor penalty

#### A) For CVI (Engg.) Eligibility

a) The staff should have completed 5 (five) years' service in Engineering department of Indian Railway (as on date of issuing this notification) and working in the posts of SSE /SE/JE and working in substantive Gr. 9300-34800; GP-4200 (6th PC) ( not under MACP) or above and the staff working in ML-8 will also considered eligible and if selected then the concerned unit / department to transfer the employee along with ML-8 element of the post to Vigilance department temporarily.

#### B) For CVI (IT) Eligibility:-

The candidate should be completed 5(five) years' service (as on date of issuing the 1) notification) with 3 years working experience of Information Technology (3 years working experience period includes the 5 years completed service period) in any department of Indian Railways and should be working in any Sr. Supervisory /Supervisory post (irrespective of department) with substantive M / L-7 / 8, GP-4600 4800 on regular basis or one level / grade below (not under MACP). Applicants of  ${\rm M}_{\odot}$ L-6 will be considered if there are no eligible candidate available from M / L-8 or M / L-7 on ad-hoc basis.

#### And

- 2) The candidate should possess any one of the following educational qualification:i) Bachelor of Computer Science.

  - ii) Bachelor of Computer Application
  - iii) B.E. / B.Tech degree in Computer Science / Information Technology from any recognized university.
  - iv) Bachelor's degree in any discipline from any recognized university

#### C) For CVI(Elect.)

Eligibility :- The staff should be:-

a] Working/having lien in the posts of SSE/SE/JE of the Electrical department of Indian Railways.

- b] Should be working in substantive Level-7of pay matrix (7th PC); GP-4600 (6th PC) or upto two level below i.e. ML-6 on regular basis (not under MACP) and the staff working in ML-8 will also considered eligible and if selected then the concerned unit / department to transfer the employee along with ML-8 element of the post to Vigilance department temporarily.
- c] having minimum 5 years service in the Electrical department.

d] Should be Diploma holder, BSc., MSc, BE or equivalent.

#### D) For CVI(Mechanical)

Eligibility: - The staff should be:-

a) Working / having lien in the posts of SSE / SE/ JE, Mechanical Inspector or equivalent

post in the Mechanical department of Central Railway.

- b) Working in substantive Gr.Rs.9300-34800 [GP-4200] (6th PC), Level-6 of Pay Matrix (7th PC) and above (Those who have received GP 4200 under MACP will not be considered in this regard) and the staff working in ML-8 will also considered eligible and if selected then the concerned unit / department to transfer the employee along with ML-8 element of the post to Vigilance department temporarily.
- c) having minimum 5 years service in the Mechanical department.

d) Diploma / Degree holder in any discipline.

# E) For CVI (Accounts) Eligibility:-

a) The staff should have completed 5(five) years service in Accounts department of Indian Railways (as on date of issuing the notification) and working in the post with substantive Pay Level-8(7th PC)/GP 4800 (6th PC) or one Level/grade below (not under MACP) on regular basis.

# F) For CVI(Pers.) Eligibility:-

- a) Railway employee who have completed 5(five) years' service (as on date of issuing notification) in Personnel department across the Indian Railways and working in substantive Level-7 of Pay Matrix (7th PC) or one level below on regular basis (not under MACP) and the staff working in ML-8 will also considered eligible and if selected then the concerned unit / department to transfer the employee along with ML-8 element of the post to Vigilance department temporarily.
- b) Those Ch.OS / OS / Ministerial staff are working in Non-Personnel departments and have completed 5(five) years' service on regular basis (not under MACP) as on the date of issuing notification, may also apply for the post.

#### G) For CVI (Stores) Eligibility:-

a) Railway employee who have completed 3(Three) years service (as on date of issuing notification) in Stores department across the Indian Railways and working in substantive Level-7 of Pay Matrix (7th PC) or one level below on regular basis (not under MACP) and the staff working in ML-8 will also considered eligible and if selected then the concerned unit / department to transfer the employee along with ML-8 element of the post to Vigilance department temporarily.

## H) For CVI(S&T) Eligibility:-

a) Working/having lien in the posts of SSE (Sig.)/SE (Sig.) /JE (Sig.) of the S&T department

b] Should be working in substantive Level-7 of Pay Matrix (7th PC) or one level below on regular basis (not under MACP) and the staff working in ML-8 will also considered eligible and if selected then the concerned unit / department to transfer the employee along with ML-8 element of the post to Vigilance department temporarily.

c] having minimum 5 years service in the S&T department.

d] Should be Diploma holder, BSc. MSc, BE or equivalent.

#### [2] Written Test :-

The written test will include questions about Railway working, writing of reports, knowledge about-Railway services (conduct) Rules, DAR Rules, Circulars, Codes, Manuals and working knowledge, rules and regulations of respective department

Candidates who obtain 60% and above marks in the written examination will be considered to be called for appearing in the Vigilance Aptitude & Computer knowledge test, subject to DAR & Vigilance clearance. Vigilance Aptitude test & computer knowledge test will be taken through viva-voce.

#### [3] General Conditions

- Applications must be forwarded through proper channel. I.
- Application should be made as per proforma enclosed and must be filled and signed II. by the candidate himself/herself giving the correct information best to his/her especially regarding SPE/Vigilance/DAR alterations/correction on the application will be entertained. Applicants must note that if any information furnished by him/her is found to be false at any stage, the application/candidature will be summarily rejected. Submission of false or misleading information by applicant will lead to DAR action. The particulars as submitted by the applicant in his/her application must be verified and signed by the concerned Supervisor, clearly mentioning own name & designation and office. While verifying the application, any additional information /alteration / correction. remarks made must be signed with date, name and designation by the verifying Authority. For correctness of the information concerned office will be solely responsible and no way Vigilance deptt. will have any responsibility in this regard. Forwarded application must have signature, stamp and office seal of the competent authority.
- The staff should have sound integrity, should not be figuring in any current III. Vigilance/SPE/DAR case and should not have been imposed any major/minor penalty in any past Vigilance case.
- Employees who are selected for the posts of Chief Vigilance Inspector are entitled for IV. Railway Quarter from the Vigilance pool, subject to availability of the same.
- The staff should have good reputation and possess good writing ability. V.
- The vigilance work is mainly out-door involving extensive travelling. The staff should VI. have interest and physical fitness for the same.
- The staff should possess sufficient knowledge of respective department VII. Working/Rules & Regulations, Circulars etc., Railway Service (Conduct) Rules and Railway Servants (Discipline and Appeal) Rules, Railway Manuals and other rules & regulations.

#### CENTERI DAILMAN

- Preference will be given to the employees who are having working knowledge of computer.
- IX. The applicants may be specifically advised that the post of Chief Vigilance Inspector is a tenure post for three years, but the Vigilance organization reserves the right to repatriate him even earlier without assigning any reason.
- X. Sufficient number of SC/ST employees may be considered while sending the recommendations for recruitment of Chief Vigilance Inspector.
- XI. The selected candidates may be repatriated to his parent department if it becomes necessary for the administration without assigning any reason or if he/she gets selected for any higher-grade post.
- XII. Forward applications of all candidates irrespective of cooling off period. The aspect of cooling off period as per HQ policy letter no. CR-HQ/PERS(PUPM)/4/2023/310136 dated 07.03.2024 amended vide letter no.CR-HQ/PERS(PIPT)/3/2024-O/o CPOA/HQ/CR dated 13.06.2024, should be checked and commented upon while forwarding the applications (Copy enclosed for ready reference).
- XIII. Attested Xerox copies of APARs for the years 2020-21, 2021-22, 2022-23 & 2023-24 of the applicants may please be sent to this office along with the application forms.
- XIV. The candidates whose names have been recommended should be relieved immediately in event of his/her selection as Chief Vigilance Inspector.
- XV. Once selected, applicants will not be permitted to withdraw and refuse posting in vigilance department.
- XVI. It may be noted that the selected candidate will have to give a written undertaking that he/she on being repatriated from Vigilance organization, will not act as Defense Assistant to any employee facing DAR enquiry arising out of Vigilance/CBI cases for four years from the date of his/her repatriation.
- XVII. No direct applications will be entertained in this office.
- XVIII. The date of written test will be intimated to the candidates later.
- XIX. It may be noted that mere being called for appearing in the written test/viva-voce no way confirms the applicant's eligibility and it will not confer any right on him / her in anyway, at any stage of this selection process and in also in any other future selection of Vigilance deptt..
- XX. Notified Vacancies are tentative and may be increased or decreased during the selection procedure as per requirement of administration.

It is requested to give wide publicity to this notification, so that eligible candidates can benefit from this.

Application of those employees who are of sound integrity and fulfilling the conditions mentioned in Para [1] and [3] above should only be forwarded.
