Sub: Revision of rates of miscellaneous charges and transportation of track machine.

Sanction is hereby accorded to revise the rates of the various miscellaneous charges and charging of 'Track Machine' owned by other than Indian Railways as given against each of them as under:

3. All the above rates for various miscellaneous charges and transportation & speed trial of track machine will come into force w.e.f. 01.04.2025 and valid up to 31.03.2026.
