The employee should be made to work in Jr Clerk (NP)Medical on the Special Supernumerary post created for the above employee at the time of de-categorization will continue to be operated till a vacancy arise in the cadre and he is accommodated till arising vacancy in cadre or till his retirement whichever is earlier. The Special supernumerary post shall be abolished once the employee get absorbed in a vacancy in the cadre where he is alternately posted/lien fixed or his retirement whichever is earlier. He will be eligible for seniority and shall be considered for promotions in the new cadre.

As a result of screening of above named employee (Gr-'C' staff) absorption on medically de-categorization in Ministerial cadre of Non-Personnel, Medical deptt/SUR Division.

As per existing instructions/guidelines issued by Railway Board, seniority of above name will be assigned in Ministerial cadre, Non-Personnel Medical department/SUR Division.
