1.1 There will be no change in the nomenclature/designation, duties and responsibilities and classification of the posts after up gradation and they will remain classified as Group 'C'.

1.2 The above named employee is entitle for fixation of pay under Rule 1313(FR-22)(!)(a)(i)(R-II) and can exercise option for fixation of pay from the next date of increment in the lower grade, within one month's time from the issue of this order as per Board's letter No. PC-VII/2016/1/2, dated 31.03.2017 (RBE No.79/2017). If no option is exercised within the stipulated period (i.e.within one month) their pay shall be fixed under Rule 1313(FR-22)(!)(a)(i)(R-II), as per Railway Board's letter no. PC-III/911/CR/1, Dated 03.03.1993.

1.3 If the above named employee has already obtained the same Pay Matrix Level/Grade Pay under MACP in terms of Railway Board's letter No.V/2009/ACP/2, dated 10.06.2009, they will not be entitled for further fixation of pay.

1.4 Also the above up gradation shall be provisional subject to outcome of various court cases pending on th subject matter.[The main SLPs and the contempt petition mentioned in the Railway Board's letter No. 2016-E(SCT)/1/25/8,dated 30.09.2016(RBE no.117/2016). SLP© No.4831/2012 & CP No. 314/2016 pending in Apex Court]

1.5 The above up gradation is subject to the condition that there is no DAR/VIG/SPE cases pending/contemplated against them, not undergoing any penalty/punishment and no NIP is pending against them as on date of effect of up gradation.

1.6 The above up gradation is provisional subject to pendency of Court Cases, if any that may be applicable in this case too
