In terms of Para 3 of CPO/CSTMS Lr. No. P/CR/HQ/RP/601- Policy dtd. 15/03/2017, Fixation of pay will be done as per extant rules on the subject. Above named employee is eligible to exercise an option within a period of one month for fixation of pay on promotion in the manner as laid down in RB's Letter No. F (E) II/89/FR-1/1 dated. 12/12/1991 Amendment to the IREC Vol. II (VI edition 87). However, those who have already awarded higher grade under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same, grade granted under MACP in reference to Para 4 of Annexure of Railway Board's Letter. No. PC - 5/2009/ACP/2 dated. 10/06/2009. Option once exercised shall be final.
