ADVANCE RATE NOTIFICATION NO. 11 of 2025 (Parcel)

Sub: Haulage charges recoverable for movement of Milk traffic in Railway Milk Tankers (RMT) owned by private parties.
Ref: 1) FM Circular No. 16 of 2025 dt 30.06.2025 and
2) FM Circular No. 15 of 2024 dt 18.06.2024, No. 11 of 2023 dt 30.06.2023 and No. 23 of 2019 dt 11.09.2019
Authority: Board's Letter No. TCII/2642/2020/Milk-Policy(3329880) dated 30.06.2025

Vide Freight Marketing Circular No. 11 of 2023 dated 30.06.2023(ARN No. 09 of 2023), it was decided to revise haulage charges for movement of Milk traffic in Railway Milk Tankers (RMT) owned by Private Parties for the period 01.07.2023 to 30.06.2024.

Further, vide Freight Marketing Circular No. 15 of 2024 dated 18.06.2024(ARN No.12 of 2024), it was decided to continue the same haulage charges for movement of Milk Traffic for the period 01.07.2024 to 30.06.2025 also.

It has been further reviewed and decided to continue the existing haulage charges for movement of Milk Traffic for an another period of one year.

2. Accordingly, the Haulage charges for movement of Milk Traffic for the period from 01.07.2025 to 30.06.2026 shall continue to be charged as per Freight Marketing Circular No. 11 of 2023 dated 30.06.2023.
3. Haulage Charges for new Rail Milk Tankers (VVNH1) shall continue to be calculated by multiplying a factor @1.12 times of the applicable Haulage charges as per FM circular no. 23 of 2019 dated 11.09.2019.
4. No Charges are to be levied for empty movements of RMTs from unloading points to the loading points for re-loading.
5. There shall be no change in other terms and conditions.
6. This issues with the concurrence of Finance Directorate of Ministry of Railways.

Necessary instructions may be issued to all concerned immediately.
