2. Performance of HCOs and Chemists
3. Infrastructure and cleanliness in RH/HU
4. Staff behavior and availability
5. Review of complaint box feedback and grievance redressal
6. Shortage of medicines
7. Suggestions for improving RH/HU operations within available resources
8. Coordination with support service agencies
9. Intimating DRM/CMS in case of serious medical emergencies
