Fixation of pay will be done as per extant rules on the subject. Employee is eligible to exercise an option within a period of one month for fixation of pay on promotion in the manner as laid down in RB's letter No. E(E)II/89/FR-1/1 dt.12/12/1991- Amendment to the IREC Vol. II (VI Edition 87). However who have already awarded higher grade under MACP scheme, is not entitled for pay fixation on his regular promotion as it is the same grade granted under MACP in reference to para 4 of annexure of Railway Board's letter no.PC-5/2009/ACP/2 dated 10.06.2009.

Transfer of a Railway servant, ordered as a result of his promotion should be carried out by the employee as early as possible in his own interest. In case, an employee who neither gives the refusal in writing nor joins duty on being promoted, it should be treated as refusal of promotion and action will be taken accordingly. It is the responsibility of controlling supervisor to inform the concerned staff accordingly and get it noted. Changes made will be intimated to all concerned.
