JURISDICTION OF THE POST :**RPF POST NAGPUR:**

The jurisdiction of RPF Thana Nagpur extends from KM No. 835 between Nagpur-Ajni Stations on the main New Delhi - Chennai trunk route and Howrah – Mumbai route KM No 950 between Darimeta- Narhker –Station(Nagpur-Itarsi route) and Chandur Bajar (exclusive) Km.No. 705.529 to Narkhed (NRKR-AMI route) Km.No. 800.963 This Thana has total jurisdiction of 210.374 KMs.

RPF POST AJNI:

The jurisdiction of this Thana extends from Ajni Station Link Cabin KM No. 835.06 to Sewagram (Inclusive). Apart from the above jurisdiction on main line, the other static units of this Thana are Ajni Yard, ELS, Repackaging Shed, Engineering DSS Depot, IOC Siding Khapri and Umrer Coal Siding between Stations Butibori and Umrer. Total jurisdiction is 76 KMs.

RPF POST WARDHA:

The jurisdiction of this Thana extends from Badnera (Exclusive) to Sewagram (Exclusive) on Main Line of Howrah Mumbai Line and on New Delhi-Chennai Trunk Route It has jurisdiction up to Bhugaon (Exclusive). It has under its jurisdiction Narrow Gauge Line from Pulgaon to Arvi. Total jurisdiction is 138 KMs.

RPF POST CHANDRAPUR:

The jurisdiction of this Thana extends from KM No. 877.25 to 762.07, Chandrapur to Chitoda. Total 115. 18 KKM on Main line. The Branch Lines are as under: -

RPF POST BALLARSHAH:

The jurisdiction of this Thana extends from Gate No. 42 A of Chandrapur station at KM No. 877.25 to KM No. 893.00 Ballarshah. This Thana has total jurisdiction of 16.75 Kms.

RPF POST AMLA:

The jurisdiction of this Thana extends from KM No. 850/23 Malkapur outer to KM No. 950 Darimetha Station on New Delhi – Chennai Trunk route. Total jurisdiction 93 KMs on main line & KM No. 874 Amla Station to KM No. 902 Bordhai (inclusive) Total – 27 KMs Branch lines.

RPF POST BETUL:

The jurisdiction of RPF Thana, Betul extends from KM No. 850/23 to KM No. 755/50, Malkapur Station to Jhuzarpur (Exclusive) on New Delhi – Chennai Trunk route.

RPF POST JUNNARDEO:

The jurisdiction of RPF Thana Junnardeo extends from KM No. 902, Outer Signal Boardhai to KM No. 989 Chhindwara (Exclusive)
