**Remarks:** - The Railway Bookstall contactor association comprising from sr. No. 1 to 32 has filed writ petition no. 1560 of 2013 before Hon'ble High court Bombay challenging the applicability of Rly. Bd's circular No. 57 of 2006 stating that the revision of license fees to 12% of annual sale turnover is highly unreasonable. By interim order dated 13.11.2013 of Hon'ble high Court has directed not to take action pursuant to the circulars. Accordingly the book stall licensees has stopped the payment of revised license fee and only remitting the license fee at the old rate Rs. 10000/- p.a.
