NOTIFICATION

Sub: Re-engagement of Retired staff on monthly remuneration basis in exigencies of services on Mumbai division, Central Railway.

In terms of Railway Board's letter no. E(NG)II/2007/RC-4/CORE/1 dated 16.10.2017 it has been decided to fill up following vacancies in Mumbai Division by re-engagement of Staff, who have retired from Mumbai Division, Central Railway.

Therefore applications of running Staff who have retired from Railway Service of Mumbai Division, Central Railway are called for to reach P/Loco section (Drop Box) of Sr.DPO's office on or before 08.08.2018.

Following terms and conditions may kindly noted:-

1. The Scheme is valid upto 01.12.2019.
2. Retired staff who have retired from Mumbai Division of Central Railway and from the same category and same department for which notification is issued can apply.
3. The re-engagement shall be strictly upto 01.12.2019 or attaining the age of 62 years or till the availability of regular candidates from RRB/Departmental Selection whichever is earlier.
4. No re-engaged employee should continue in service beyond 62 years of age.

5. The Administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/ conduct is found unsatisfactory by giving a notice of 7 days.
6. The employees Removed / Dismissed/ Compulsory retired as a result of disciplinary action or in review , are not eligible for re-engagement. Further employees retired under SRRS/LARGESS will not be eligible.
7. The re-engaged employees are entitled only for monthly fixed remuneration i.e reducing pension from his/her last pay drawn, (i.e. Basic+DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
8. The Re-engaged employee will not be eligible for any kind of leave (like CL, APL, Sick Leave etc). For absence if any, appropriate deduction will be made from the monthly remuneration.
9. The re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.
10. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
11. Re-engagement shall be subject to prescribed medical fitness for the relevant Category.
12. Suitability / Competency of the applicant shall be adjudged by nominated committee before their re-engagement.
13. The duty hours of the re-engaged employees would be as per extent rule. The duty can be changed as per the requirement of works by the administration with weekly off for one day.
14. Copy of any of the following documents should be attached with the application & it is Mandatory.
 - a. Service certificate,
 - b. Pensioner Identity Card,
 - c. Pension Payment Order.
15. The last date for submission of the application is 08.08.2018. Running Staff retired from Mumbai Division Central Railway desirous for re-engagement; have to submit their applications in the prescribed format at Annexure A in the box kept in P/Loco Section of this office on or before 08.08.2018.
