NOTIFICATION

Sub: Re-engagement of Retired staff on monthly remuneration basis in exigencies of services in Accounts Office, Central Railway.

In terms of Railway Board's letter No. E(NG)-II/2007/RC-4/CORE/1 dated 28/11/2019, it has been decided to fill up following vacancies in various Gr.C cadres in Accounts Office by Re-engagement of Staff, who have retired from Accounts Department. **Sr.TIA : 06, Sr.ISA : 02, Sr.ASV : 01**

Hence applications of retired Staff of Accounts Department who have retired from Railway Service are called for to reach HQ Admn Section of PFA's Office, Mumbai CSMT on or before **03/02/2020** on following terms and conditions.

Terms and Conditions of re-engagement of retired staff

1. The Scheme is valid upto 01/12/2020.
2. Retired Railway Staff of Accounts Department of above mentioned cadres can only apply.
3. The re-engagement shall be strictly upto the age of 65 years on or before 01/12/2020 or till the availability of regular candidates from RRB/Departmental Selection whichever is earlier.
4. The maximum upper age limit for the Re-engagement of staff is 65 years. No re-engaged employee should continue in service beyond 65 years of age.
5. The Administration is at liberty to terminate the services of the re-engaged employees even before 01/12/2020 in case their work/ conduct is found unsatisfactory.
6. The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review, are not eligible for Re-engagement. Further employees retired under SRRS/LARGESS will not be eligible.
7. The monthly remuneration for re-engaged staff is determined by reducing pension from his/her last Basic Pay drawn, as per Railway Board's letter no. E(NG)II/2007/RC-4/CORE/1 dated 24/10/2019. The re-engaged employees are entitled for Daily Allowance as per Railway Board's letter No. F(E)I/2015/AL-28/58 dated 16/03/2017, wherever applicable.
8. The re-engaged employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
9. Re-engagement shall be subject to prescribed medical fitness.
10. Suitability / Competency of the applicant shall be adjudged by competent authority before their re-engagement.
11. The Re-engaged Retired employee will have to give 7 days' Notice for discontinuing the service.
12. Re-engaged employees shall be on duty on normal duty hours followed by the office in which they will be posted. The duty hours can be changed as per the requirement of work by the administration. They will be eligible for weekly off and General Holidays observed by the office in which they will be posted. In terms of Railway Board's letter no. E(NG)II/2007/RC-4/CORE/1 Pt.I dated 24/07/2019, 8 days leave (on prorata basis) in a calendar year will be admissible to Re-engaged employees.
13. Copy of following documents should be attached with the application and it is mandatory.
a) Service certificate, b) Pensioner Identity Card, c) Pension Payment Order
14. The last date for submission of the application is **03/02/2020**. Staff retired from Railways desirous for re-engagement, have to submit their applications in the prescribed format at Annexure 'A' and submit to **HQ Admn Section** of PFA's Office, Mumbai CSMT on or before **03/02/2020**.
15. The posting will depend on vacancies on Central Railway and as per administrative requirements.
