ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS ON FULL-TIME BASIS
WALK-IN-INTERVIEW

A walk-in interview will be held from **Open Market and from Retired Doctors of Railways, State & Central Government** for selection to the post of CMP GDMOs at Bhusawal division of Central Railway for the Doctors who fulfill the eligibility criteria specified below.

For CMP GDMOs from Open Market : The engagement will be offered **purely on contract basis** for a period of one year or less from the date of contract, which can be renewed as a fresh contract on year to year basis, subject to extension of delegation of power to DRM beyond one year, not extendable beyond 10 terms or till such time Doctors selected by UPSC become available, whichever is earlier.

For Contract Medical Practitioners from Retired Doctors of Railways, State & Central Government : The engagement will be offered **purely on contract basis** for a period of one year or less from the date of contract, which can be renewed as a fresh contract on year to year basis, subject to extension of delegation of power to DRM beyond one year, not extendable beyond 05 terms or attaining the age of 65 years or till such time Doctors selected by UPSC become available, whichever is earlier.

(A) Vacancies : Total vacancies notified are 05, (**Genl=01,SC=1,ST=1 & OBC=02**) which will be filled from Open Market and from Retired Doctors of Railways, State & Central Government.

Percentage of reservation between UR, SC, ST, & OBC as per recruitment rules will be maintained.

Note :

- 01. Number of posts and locations are subject to change.** Offer will be on the basis of vacancies available at the time of engagement.
02. Posts indicated herein may be kept unfilled at the discretion of administration.
03. Contract can be terminated by the Railway at any time during the contract period by giving 15 days notice without assigning any reason as per the terms and conditions laid down vide Railway Board's letter No. 96/E(GR)II/9/16 dated 23.02.2000 and No. 2008/E(GR)II/1/1 dated 16.07.2012.
04. CMPs who enter into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as full-time contract Doctors will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer any right for regularization or absorption.
- 05. Eligible SC/ST/OBC candidates may apply along with necessary caste certificate. OBC candidates have to submit certificate in Central Government format to the effect that they do not belong to Creamy Layer, from appropriate authorities.**

(B) Remuneration :

(a) For Open Market Candidates :

	Monthly fee
(i) CMP GDMOs	Rs. 75,000/- per month.

The remuneration specified above includes the following amount as HRA in case of full-time contract doctors.

CMP GDMOs : Rs.5250/-

If Railway accommodation is provided, HRA and licence fee of the accommodation so provided will be deducted from the monthly fee admissible to the concerned Medical Practitioners.

(b) For Retired Doctors of Railways, State & Central Government :

Retired Doctors of Railways, State & Central Government engaged as CMP : Rs.46000/- per month (remuneration + pension drawn by retired Doctors of Railways, State & Central Govt. should not exceed the last pay drawn).

The Retired Doctors of Railways, State & Central Government engaged as CMPs will be provided with Railway accommodation at places where earmarked Railway accommodation for Railway Doctors is vacant/ available after meeting the residential requirement of the serving Railway officers. In case Railway accommodation is provided to the Contract Medical Practitioner (Retired Doctors of Railways, State & Central Government) an amount equivalent to HRA payable to a fresh entrant to Group 'A' Jr. Scale and licence fee of the Railway accommodation so provided shall be deducted from the monthly remuneration payable to the Contract Medical Practitioner.

(C) Age :

- (i) For Open Market** : Not exceeding 50 years as on 15.06.2020. Relaxation for SC/ST/Ex-servicemen : 5 years and for OBC : 3 Years.
- (ii) For Retired Doctors of Railways, State & Central Government** : Not exceeding 65 years as on 15.06.2020.

(D) Educational/Professional Qualifications for CMP GDMOs:-

1. Degree in Medicine i.e., MBBS (recognized by the Medical Council of India, included in the first or second schedule or part eleven, of the third schedule (other than the Licentiate qualifications to the Indian Medical Council Act, 1956). Holders of educational qualifications in part II of the third schedule should also fulfill the condition stipulated in Section 13(3) of the Indian Medical Council Act, 1956.
2. For Dental Surgeon BDS Degree Certificate.
3. Candidates should have satisfactorily completed the compulsory Rotatory Internship.

4. For Specialists :

- (a)** Degree in Medicine i.e. MBBS recognized by Medical Council of India.
- (b)** A Post Graduate qualification in the relevant subject/Field recognized by the Medical Council of India.
- (c)** Three years experience in Clinical work after Post Graduation in the specialty concerned as on the date of interview is desirable.

(E) Doctors serving under State/Central Govt./Public Sector undertaking etc, may apply with 'NOC' from the date respective originations.

(F) Doctors while applying should indicate past service rendered, if any, including the period of contract put in by them on all over Indian Railways.

(G) Those fulfilling the above conditions may **WALK-IN** for an Interview along with application in the format (Please check the website) and **all original certificates/testimonials**, duly enclosing **attested copies of certificates / testimonials** between **10.00 hrs & 13.00** hrs on the date and place mentioned below :
