In terms of Railway Board's letter No. 2018/Trans Cell/S&T/Contractual Staff dated 25.10.2018, it has been decided to re-engage 01 retired Gr "B" officer/PS-I on contract basis as Consultant (PS-I to PCEE) in exigencies of the services.

- 1 Detailed terms and conditions are enclosed .
- 2 Age-Maximum age limit for re-engagement shall be 65 years.
- 3 Honorarium- Monthly remuneration of retired officer being re-engaged will be determined in terms of instructions contained in Board's letter No.2018/Trans cell/S&T/Contractual Staff dated 25.10.2018 & 20.12.2018 i.e. by reducing Pension from his /her last pay drawn ( i.e. Basis Pay + D.A). In the event of absence from duty, there shall be proportionate deductions from remuneration.
- 4 Officers retired from Senior Scale ( not above Senior Scale) may be considered for re-engagement against the Junior Scale post, if willing to be re-engaged, on the same terms and conditions as issued for Re-engagement of retired Gazetted Officers in exigencies of services vide Railway Board's letter No. 2018/Trans Cell/S&T/Contractual Staff dated 25.10.2018, except the remuneration.
- 5 Monthly remuneration of a retired Senior Scale Officers being re-engaged against the Junior Scale post be determined by reducing Pension from his/her last pay drawn (i.e. Basis Pay + DA) by the officer in Junior Scale/Group 'B' just before the promotion to Senior Scale minus the pension of the retired officer. In case the last working of the retired Senior Scale Officer, re-engaged , in Junior Scale/Group 'B' post, was during VI CPC, then the corresponding amount can be worked out by applying 2.57 fitment factor and notional placement in the corresponding pay scale to ascertain corresponding VII CPC pay.
- 6 Re-engaged officer shall not be entitled for requisites such as HRA, CCA, Transport Allowance, Residential accommodation, etc. However, when required to travel in connection with official work. TA/DA admissible to regular employee working in the same Grade will be admissible.
- 7 **The eligible and willing officers should submit their applications in the prescribed format at Annexure-A on or before 26/06/2020 in PCPO's office, CSMT.**
- 8 **The officers found suitable for re-engagement should be ready to serve in PCEE's office as Consultant /PS-I to PCEE.**

**Terms & condition for re-engagement of Gazetted Railway officers on contract basis against the vacant post of PS-I to PCEE as Consultant /PS/I to PCEE in exigencies of service**

1	The re-engaged retired Officers will be engaged in Jr. Scale/ Gr. 'B' as Consultants/PS-I to PCEE.
2	All work/duties attached to PS-I and day to day work as directed by Controlling Officer would be the responsibility.
4	They will not sign on behalf of President of India in any contract, agreement and will not represent the Railways in any meetings.
5	Such re-engaged retired officers will not be part of any selection committee/tender committees. They will not certify M. Book or certify any document.
6	The re-engaged retired officers will not handle Confidential/Secret papers/Assignments.
7	Suitability/Competency of the retired officer shall be adjudged before such re-engagement by a committee of three PHODs/CHODs/SAG as appointed by GM.
8	While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing provisions.
9	The period of engagement shall be upto 24.10.2020 or till regular incumbent is posted, whichever is earlier.
10	Maximum age limit of the re-engagement shall be 65 years.
11	The engagement of consultant shall not be considered as a case of re-employment.
12	12 days leave in calendar year on pro-rata basis is admissible.
13	Re-engaged officers shall not be entitled for requisites such as HRA, CCA, Transport Allowance, Residential accommodations, etc. However, when required to travel in connection with official work, TA/DA admissible to regular employee working in the same Grade will be admissible.
14	The designation shall be consultant followed by ( trade name) i.e. Consultant/PS-I to PCEE
15	Re-engaged officer shall not be made in charge of the unit like Branch Officers in the Division or independent in charge in the Construction unit.
16	Re-engaged officer shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate.
17	The consultant shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know/have the same.
18	Re-engaged officer shall be discharged immediately on joining of selected candidates from departmental selection or as per the recommendation of PHOD/CHOD concerned.

19	Monthly remuneration of a retired Senior Scale Officers being re-engaged against the Junior Scale post be determined by reducing Pension from his/her last pay drawn (i.e. Basis Pay + DA) by the officer in Junior Scale/Group 'B' just before the promotion to Senior Scale minus the pension of the retired officer. In case the last working of the retired Senior Scale Officer, re-engaged, in Junior Scale/Group 'B' post, was during VI CPC, then the corresponding amount can be worked out by applying 2.57 fitment factor and notional placement in the corresponding pay scale to ascertain corresponding VII CPC pay.
20	Officers retired from Senior Scale ( not above Senior Scale) may be considered for re-engagement against the Junior Scale post, if willing to be re-engaged, on the same terms and conditions as issued for Re-engagement of retired Gazetted Officers in exigencies of services vide Railway Board's letter No. 2018/Trans Cell/S&T/Contractual Staff dated 25.10.2018, except the remuneration.
21	This scheme is experimental in nature and is valid for two years from the date of issue of Board's letter dated 25.10.2018 (i.e. upto 24.10.2020)
22	The re-engagement shall be strictly be up to age of 65 years or till the availability regular candidates from departmental selection or as per the recommendations of PHOD/CHOD concerned. No re-engaged officers will continue in service beyond 65 years of age under any circumstances.
23	The Administration is at liberty to terminate the services of the re-engaged officers even before the age of 65 years in case their work/conduct is found unsatisfactory.

**Officers retired from Railways and desirous of re-engagement, should submit their applications in the prescribed format at Annexure - A in PCPO's office, CSMT on or before 26.06.2020.**
