

Sub: Colony Inspection Groups (CIG)

Railway Board vide letter No2014/LMB-II/1/1(A) dt.25.7.2014 has advised for the constitution of Colony Inspection Groups in which Personnel department has been given the role of coordinator of the CIG except for in roadside stations, where the SE/Works shall be coordinator if headquartered there. Wherever SE/Works are not headquartered at roadside station, SS/SM shall act as coordinator.

As per directives of Railway Board, CIG's shall recommend the staff welfare works/Maintenance works in planned manner duly prioritizing them based upon availability of resources. In view of the same, you are advised to ensure that all CIG Committees are duly constituted, if not already done so, and they inspect and hold meetings as per laid down schedule. **CIG Committees should ensure that their report/minutes of the meetings clearly lay down the priority as per which maintenance work will be carried out by the concerned departments.**

Further, you may also advise all the related Branch officers that, whenever a maintenance plan is prepared, the priority laid down by the CIGs are adhered to.
