With reference to above, it is submitted that, ATS (Anti Tout Squad) team collected information from reliable sources in station and city limits and checks have been conducted in co-ordination with RPF and Vigilance Department against the person involved in touting and e-tickets activates. Results achieve by ATS team during the month of December 2020 and January 2021 is as under.

1) On 03.12.2020, check was conducted in Mankhurd city area and apprehended Shri Sandip Kumar Verma, age 32 yrs, and seized 01 JCR Tatkal ticket of Rs. 2880/-. He was handed over to RPF Mankhurd and case vide CR. 826/2020 registered by RPF against him.

2) On 04.12.2020, check was conducted near LTT station near garden and apprehended Shri M D Mokin Ansari, age -35 yrs, seized 2 JCR YTS tickets of Rs. 485/-. He was handed over to RPF LTT and case vide Cr No.720/2020 registered by RPF against him.

3) On 11.12.2020, check was conducted at Ray Road and apprehended Shri Shamim Shaikh, age 49, seized 68 E tickets of Rs.62545/-. He was handed over to RPF CSMT(M) and case vide Cr No. 816/2020 registered by RPF against him.

4) On 23.12.2020, check was conducted at Vashi Naka and apprehended Shri Shakil Choudhary, age 42, seized 59 E tickets of Rs. 89832/-. He was handed over to RPF Kurla and case vide CR No. 760/2020 registered by RPF against him.

5) On 23.12.2020, check was conducted at Vashi Naka and apprehended Shri Narendra Prajapati, age-29 yrs, seized 273 E tickets of Rs. 491150/-. He was handed over to RPF Kurla and case vide CR No. 761/2020 registered by RPF against him.

6) On 14.01.202, a check was conducted at Darukhana Sewri-Ray road city limit and apprehended 04 touts 1) Shri Rajpal Jain, age -31 yrs, seized 13 live tickets amount 18712/- and 18 past ticket amount 27794/-. 2) Babul Main, age 39 yrs, seized 02 live tickets of Rs. 2396/- and 08 past tickets of Rs. 1777/- .3) Sharif V Pathan age 32 yrs, along with his partner Rizwan and seized 01 live

tickets of Rs. 712/- and 24 past tickets of Rs. 44205/-. 4) Sanjay Gupta age 29 yrs, seized 01 live tickets of Rs. 1620/-.


All the above 05 touts were handed over to Inspector/RPF/LTT and a case vide Cr. No. 70/2021 to 73/2021 registered against them.

7) On 28.01.2021 a check was conducted at Sativali, Vasai East and apprehended Shri Chandrapraksah Maurya, age-30 yrs, from his shop name Rajlaxmi mobile Shop, near Mourya Naka and seized 13 live tickets Rs. 18433/- and 02 past tickets of Rs. 1740/- . He was handed over to RPF Kurla and a case vides CR No. 55/2021 registered by RPF against him.

During above checks 03 JCR tickets amount Rs. 3365/-, 400 E-Tickets amount Rs. 643527/-, 30 Live tickets amount Rs. 41873/- and 52 past tickets amounting Rs. 75516/-. **In all 485 Tickets amounting Rs 764,281/- were seized.**

Further ATS team is instructed to organizes more checks against touts activates. Similarly DCTI/CSMT and CTI/Details have been instructed to brief the instructions issued vide letter under reference among staff and to be more alert during checking.
