



NOTIFICATION

ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS, ON FULL TIME CONTRACT BASIS FOR A PERIOD OF THREE MONTHS FROM THE DATE OF THEIR JOINING OR TILL 31/03/2022 OR TILL THE PANDEMIC OF COVID-19 CONTINUES WHICHEVER IS EARLIER.

Walk-in-interview will be held on 24/01/2022 for the engagement of Medical Practitioner from open market for the post of CMP, on full time **contract basis** who fulfill the eligibility criteria specified below for a period of 3 months from the date of their joining or till 31/03/2022 or till the pandemic of COVID-19 continues, whichever is earlier.

The engagement will be offered purely on contract basis for a **period of 3 months** from the date of their joining or **till 31/03/2022** or till the pandemic of COVID-19 continues **whichever is earlier**. Preference will be given to those, who can join immediately to Dr. B.A.M. Hospital/Byculla.

(A) Vacancies : Total vacancies notified are 11, which will be filled from Open Market

- a) Since the posts are over and above the sanctioned cadre due to the exigencies on temporary measure, no prescribed community distribution (SC/ST/OBC) is applicable. However, age relaxation will be given to candidates belonging to SC/ST/OBC category as per extant rules. Age will be reckoned as on the date of notification.
- b) **The vacancy is provisional and may increase or decrease as per administrative necessity.** There may be 'wait-listed/stand-by' candidates against the notified panel/select list who may be engaged as per necessity.
- c) Number of posts and locations are subjected to change. Offer will be on the basis of vacancies available at the time of engagement.
- d) If required number of Physician or Anaesthetist/Intensivists are not available, then the vacant post/posts will be filled by GDMO.

Note:

- 1) Posts indicated herein may be kept unfilled at the discretion of administration.
- 2) Contract can be terminated by the Railway at any time during the contract period by giving 15 days' notice without assigning any reason as per the terms and conditions laid down vide Railway Boards letter No. 96/E(GR) II/9/16 dated 23/02/2000 & No. 2008/E(GR) II/1/1 dated 16/07/2012, 28/03/2020 and 31/03/2020.
- 3) CMP's doctors, who enter into contract with the railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as fulltime contract Doctors will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer upon them any right for regulations or absorption.
- 4) Eligible SC/ST/OBC candidates may apply along with necessary caste certificate. OBC candidates have to submit certificate in Central Government format to the effect that they do not belong to Creamy Layer, from appropriate authorities.
- 5) Shortlisted candidates will have to pass the prescribed medical examination.
- 6) Duties of engaged doctors will be allocated by MD/Byculla.

(B) Remuneration

(D) Educational/Professional qualifications

For Specialists :

1. Degree in Medicine i.e., MBBS recognized by the Medical Council of India.
2. A Post Graduate qualification in the relevant subject/field recognized by the Medical Council of India.
3. Three years experience in Clinical work after Post Graduation in the specialty concerned as on the date of interview is desirable.

For GDMO :

1. Degree in medicine i.e. MBBS (Recognised by MCI included in the first or second schedule or part eleven of the third schedule (other than the licentiate qualifications to the Indian Medical Council Act 1956.) holders of educational Qualification in part II of the third schedule should also fulfil the condition stipulated in section 13 (3) of the Indian Medical Council Act 1956.)

- 2 Candidates should have satisfactorily completed the compulsory rotating internship.
- (E) Doctors serving under State/Central Govt./Public sector undertaking etc may apply with NOC from the respective organization.
- (F) Doctors while applying should indicate past service rendered, if any including the period of contract put in by them on all over Indian Railways.
- (G) Applications in the prescribed format (please refer to www.cr.indianrailways.gov.in) along with original and attested copies of certificates/testimonials should be produced.
- (H) Original document verification of only selected candidates will be done at the time of joining and in case of any discrepancies, the next candidate from the wait list will be called for joining.
- (I) No accommodation/Pass/PTO will be provided.

This is purely a temporary measure and after expiry of 3 months or after 31/01/2022 whichever is earlier, the status quo ante will be restored with regard to total strength and delegation of power unless extended by further orders.

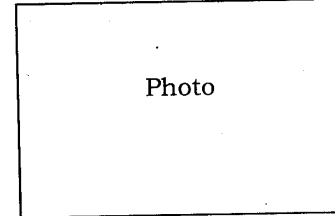
