Sub: Permission for stacking/removal of parcels to be loaded into/unloaded from 'Indented Parcel Vans' and 'Indented Parcel Trains'.

Instructions have been issued by Railway Board in regard to stacking/removal of parcels from indented parcel trains vide letter under reference.


As regards permission and time for advance stacking of parcels at originating stations as well as time for removal at the destination station clarification has been issued by Railway Board vide letter under authority. Extract of the same is reproduced below:

In the matter of stacking permission for indented Parcel Vans, it has been decided that permission and time for advance stacking at the originating station, as well as time for removal at the destination station, may be granted similar to the provisions already available in the 'Comprehensive Parcel Leasing Policy (CPLP)' as applicable for leased Parcel Vans.

However, it shall be ensured that stacking permission is not granted on platforms where passenger-carrying trains are also dealt with, and that there is no unnecessary stacking within the Railway premises.

This issues in consultation with Coaching Directorate, and with the concurrence of Finance Directorate of Ministry of Railways.

Concerned staff to note and act accordingly.
