
- 1) The re-engagement will be offered purely on contract basis up to 21.02.2023 from the date of contract.

- 3) **Age Limit** : Maximum 65 years
- 4) **Applicants Eligibility** : Work related to Survey, updation of land records, coordination with State Government agencies for forest / wild life clearances in projects where land acquisition is involved.
  - (i) The applicant must have been retired from the post of Tehsildar/Nayab Tehsildar/Head Clerk/Office Supdt and Chief Office Supdt etc or equivalent ( GP 4200/- to 5400/-) or EQUIVALENT from Revenue /Forest deptt
  - (ii) These retired Officials must have dealt with work related to survey, updation of land record etc. in forest/Revenue Dept. during their tenure in concerned state department.
- 5) **Termination of Contract:** The contract may be terminated by either side by giving one month's notice. The performance monitoring of retired re-engaged State Government staff shall be done on regular basis and those who are unable to discharge the duties or who fail to perform as per expectations of the administration, may be given 30 days' notice and their contract terminated. However, in case of gross negligence/misconduct/ irregularities, the engagement may be terminated with immediate effect.
- 6) **Remuneration, Allowances and Leave:**
  - (i) A fixed monthly amount will be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed will be remain unchanged for the term of the contract.
  - (ii) No increment, Dearness Allowance and HRA will be allowed during the term of the contract.
  - (iii) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed will remain unchanged during the term of appointment. However, they may allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
  - (iv) Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of service.
- 7) The re-engaged retired employees has to sign an agreement of confidentiality with the Railway containing a clause on Ethics and Integrity.

- 8) The selected retired staff has to undergo medical examination for medical fitness of the appropriate category from the designated authorities.
- 9) Removed/Dismissed/Compulsorily Retired employees are not eligible for re-engagement.
- 10) The retired employees selected for re-engagement shall strictly abide by all the terms and conditions of the re-engagement scheme from time to time.
- 11) Each case should be seen on case to case basis as regards need and merits.
- 12) The integrity aspect should also be checked while permitting such re-engagement.
- 13) Shortlisted candidates after scrutiny of valid applications may be intimated via Mobile/E Mails(Kindly provide valid details. May kindly check Central Railway's website for updates.
- 14) The application in duplicate with latest photograph along with copy of PPO (Submission of PPO is mandatory) may be submitted to **Dy.
