It has been decided to fill up the posts of CCOR/PCOR/TLC in accordance with the modified scheme on the above subject. The eligible Loco running staff Viz. Loco Pilot (Mail), Loco Pilot (Passenger) and Loco Pilot (Goods) having 75000 kms actual driving experience as driver as per Rly Bd's letter dated 26.3.2009, may submit their willingness for the above post.

### 1) Eligibility condition

The loco running staff from LPG,LPP,LPM, categories having a minimum of 75000 Kms . of actual driving experience are eligible to volunteer for drafting as Crew Controller /TLC/PCOR

The eligible employees will be subjected to screening test and those who are found suitable in the screening test will be drafted as Crew Controller /TLC/PCOR on their existing pay on tenure basis.

Medically decategorised drivers Up to Aye-3 medical classification who have minimum of 75000 Kms . of actual driving are eligible to volunteer as Crew Controller /TLC/PCOR .

## 2) Tenure

- a) Running staff drafted to perform the duties of Crew Controller will be three years with a cooling off period of equal duration.
- b) In case of Medically decategorised drivers, the tenure rule of three years under item 2(a) above will not be applicable .  
Continuance will depend on their satisfactory performance .

## 3) Allowance

Drivers drafted to perform such duties will be eligible for payment of allowance in lieu of kilometrage of 120 kms. per day at the rates applicable to them even if posted at their Headquarters .Medically decategorised staff of Running Cadre will not be eligible for TA/DA. and also they are not entitled for 120 Kms. per day.

## 4) Lien and seniority


Drivers as drafted will continue to progress in the running cadre and will be subjected to all the terms and conditions of service as applicable to running staff including pay and allowances, periodical Medical Examination, selection, suitability tests etc. The lien and seniority of the loco pilots so drafted will be maintained in their parent cadre from where they have been drafted .

The eligible staff may apply in the enclosed proforma and forward their application to this office through controlling supervisor.

**Selection Schedule:-** The following schedule must be strictly adhered to:

- a) Date by which willingness to be submitted to Depot- In-charge : 10/10/2022
- b) Date of submission of application controlling supervisor to  
DRM (P) office, Nagpur by : 17/10/2022
- c) Date of publication of list of eligible staff after necessary  
scrutiny of applications received : 31/10/2022
