The above candidates have fulfilled the following conditions.


- 1) Accepted offer of appointment on the conditions mentioned in Agreement Bond.

In case they are leaving the Job/Appointment they have to refund the stipend plus training cost and 12.1/2% P.A interest thereon. They will be governed by New Pension Scheme in terms of Rly Bd's Letter No. F(E) 2003/PNI/24/dated 31/12/03 & 2002/AC II/21.1 dated 27/02/2004 to contribute 10% of their pay + dearness allowance for the New Defined contributory scheme.

In terms of RB's Lr.No. E(MPP)2019/3/50 dtd.05.06.2020 (RBE No.42/2020), the newly recruited Helper should be imparted 04 weeks training for Helper(Sig) & Helper (Tele) once after joining.(Induction to Unskilled).
