Sr. No. 18, 20, 28 30, 35, 40, 42, 43, & 47 to 49 are eligible for all facilities on transfer account.

The LP(Goods) who are now working as CCOR/PCOR, will be promoted on Proforma basis.

Sr. No.22, 26, 28, 29, 34, 40, 41, 45 & 46 are promoted against UR roster point, will be set off in future point.

Sr. No. 18, 24 & 50 are promoted against ST roster point.

Fixation of pay on promotion will be done as per extant rules on the subject. Employees are eligible for fixation of pay on promotion from the date of shouldering higher responsibilities. The date of shouldering higher responsibilities along with option for fixation of pay, if eligible, should be forwarded to this office immediately for timely fixation of pay. The above promotion order is provisional and subject to the conditions that there is no DAR/SPE/Viz case pending or contemplated or proposed to be initiated. The above promotions are subject to result of Supreme Court/ High Court/ CAT decisions. The promotion is also subject to disposal of writ petitions / appeals / applications pending in various courts as the case may be in occupation before carrying out the transfer/ promotion order. All the promotions shall be subject to outcome of the main SLPs & contempt petition mentioned in the railway Board's Lr. No. 2016-F(SCT)1125/8 dt.30/09/2016 (RBE No.117/2016) & as per instructions of HQ Lr. No. P/HQ/Ruling /O/817 dt. 04.10.2016 & clarification of HQ's Lr. No. P/CR/HQ/RP/601- Policy dt. 15/03/2017.
